

MEMORANDUM OF UNDERSTANDING

The parties agree to modify Article 20.1 as indicated below due to the 2022-2023 fiscal year having 27 bi-weekly pay periods. The modified salary schedules indicate the bi-weekly salary amounts change to accommodate 27 pays, while keeping the annual salary amount, daily rate, and hourly rate the same as in the 2021-2022 fiscal year.
