

## AN IMPORTANT MESSAGE FROM CAMBRIDGE ISANTI SCHOOLS FOOD SERVICE DEPARTMENT

Dear **Parent / Guardian**,

Welcome to Cambridge Isanti Schools. Please find below some information regarding Food Service. When your child is enrolled in our school district an account is automatically created. We do have family meal accounts so if you have more than one child enrolled in the district they will each have a key pad number, but they will share one account for the family.

Our school offers healthy meals each day. Starting school year 2023-24, we are joining Minnesota's Free School Meals Program. All students can get one breakfast and one lunch free of charge each day at school. Although no application is required to receive this free meal benefit, filling out the Application for Educational Benefits is still important! Your child(ren) may qualify for other benefits like reduced fees for Athletics and Activities, Community Education, ACT/AP Testing and more. Your application may also help the school qualify for education funds, discounts, and other meal programs.

### FREE AND REDUCED MEAL APPLICATIONS

Applications can be submitted online by logging into Family Access and choosing Food Service. Applications must be completed each school year and should be received before the first day of school to ensure your child(ren) receive the Free/Reduced benefits for the first day of meals. If you don't qualify at this time, but have a change in income or family size during the school year, you may reapply for Free/Reduced meals at any time. When your application has been processed you will receive a letter emailed to you or in the mail stating your eligibility.

**Free and Reduced Eligibility Letter:** Your children may qualify for a reduced fee for Activities / Athletics and Community Education classes based on your approval for Free and Reduced meals. **Please retain the letter of approval received from Food Service. It is your responsibility to share your approval letter with these departments, when paying for activities for your children, to qualify for the reduced fee.**

### FOR YOUR CONVENIENCE, WE OFFER SEVERAL PAYMENT OPTIONS

**\*\*\*LIVE** MasterCard, Visa or Discover credit or debit card or checking account information. No more worrying about the 10:00 am deadline. Immediately after you enter your payment, it is available to your students for their meal purchases. Go to [www.c-ischools.org](http://www.c-ischools.org), choose **Family Access**, and follow the prompts.

**Service Fee:** We are happy to announce that there is **never** a service fee for any type of payment to your family food service account.

**\*\*\*Low Account Balance Reminder:** You can sign up to have an e-mail reminder sent to you when your family account balance falls below \$10.00. Go to **Family Access** and choose **E-mail Notification** in the left hand column.

**Automated Payments:** Please consider setting up automated payments! This feature can be enabled through Family Access → Food Service → Select Student → Make Payment → Enable Auto Replenish

**Payment Drop Boxes:** Located in the office at each school and at the Food Service Office in the Education Services Center at 625A Main St. North in Cambridge. Payments placed in the drop boxes by 10:00 a.m. will be credited to the account the same day. Payments made after 10:00 a.m. will be credited to the account the following day.

**Cash Payments:** Place cash payments in a sealed envelope with the student(s) **first and last name** and **key pad number** printed legibly on the envelope. This is very important to ensure placement of payments in the correct account.

**Check Payments:** Please print the student(s) first and last name and key pad number in the memo section of the check. This is very important to ensure placement of payments in the correct account.

**Student Information:** The Skyward Student Management System allows parents/guardians to access student information over the internet. This program enables parents/guardians to view their student's current and previous lunch purchases, food service payments, account balance, as well as student academic information.

**Ala Carte Items:**

**If you do not wish for your child(ren) to purchase ala carte items or you wish to set a daily limit:**  
This can be modified at Family Access→Select Student→Food Service→Set Purchase Limit→"Set Purchase Limit/Do Not Allow:→Save

**Insufficient Funds Policy:**

**The following procedures are in accordance with Board Policy 534 – Food Service Management. All District policies may be reviewed at <http://www.c-ischools.org/policy-manual>**

**The school district will make reasonable efforts to notify families when meal account balances are low or negative.**

**Students can purchase a breakfast and lunch regardless of their account balance. When a student has a negative account balance, the student will not be allowed to purchase A la Carte items such as a milk, second entrée or any other item considered to be A la Carte.**

**Who should complete this application?** Children in households participating in the Supplemental Nutrition Assistance Program (SNAP), Minnesota Family Investment Program (MFIP) or Food Distribution Program on Indian Reservations (FDPIR), and foster, homeless, migrant and runaway children qualify without reporting household income. Alternatively, children can qualify if their household income is within the maximum income shown for their household size on the instructions.

### **COMMON QUESTIONS:**

**I get WIC or Medical Assistance. Can my children qualify?** Children in households participating in WIC or Medical Assistance do not automatically qualify. Children may be eligible depending on other household financial information. Please fill out an application.

**Who should I include as household members?** Include yourself and all other people living in the household, related or not (such as grandparents, other relatives, or friends).

**May I apply if someone in my household is not a U.S. citizen?** Yes. You or your children do not have to be U.S. citizens for you to complete an application.

**What if my income is not always the same?** List the amount that you normally get. If you normally get overtime, include it, but not if you get overtime only sometimes. For seasonal work, write in the total annual income.

**Will the income information or case number I give be checked?** It may be. We may also ask you to send written proof.

**How will the information be kept?** Information you provide on the form, and your child's approval, will be protected as private data. For more information, see the back page of the Application for Educational Benefits.

**If I don't qualify now, may I apply later?** Yes. Please complete an application at any time if your income goes down, your household size goes up, or you start getting SNAP, MFIP or FDPIR benefits.

## How to Complete the Application for Educational Benefits

Complete the Application for Educational Benefits form for school year 2023-24 if any of the following applies to your household:

- Any household member currently participates in the Minnesota Family Investment Program (MFIP), or the Supplemental Nutrition Assistance Program (SNAP), or the Food Distribution Program on Indian Reservations (FDPIR) or
- The household includes one or more foster children (a welfare agency or court has legal responsibility for the child) or
- The total income of household members is within the guidelines shown below (**gross earnings before deductions**, not take-home pay). Do not include as income: foster care payments, federal education benefits, MFIP payments, or value of assistance received from SNAP, WIC, or FDPIR. Military: Do not include combat pay or assistance from the Military Privatized Housing Initiative. The income guidelines are effective from July 1, 2023 through June 30, 2024.

### Step 1: Children

List all infants and children in the household, their school and grade if applicable, and birthdate. Attach an additional page if needed to list all children. Check the box if a child is in foster care (a welfare agency or court has legal responsibility for the child).

### Step 2: Case Number

If any household member currently participates in SNAP, MFIP or FDPIR, write in the case number and then go to Step 4. If you do not participate in any of these programs, leave Step 2 blank and continue on to Step 3.

### Step 3: Adult and Child Incomes / Last 4 Digits of Social Security Number

- **Social Security Number/Total Household Members.** An adult household member must provide the last four digits of their Social Security number or check the box if they do not have a Social Security number. Report the total number of household members and ensure all household members are listed individually on the application in the child or adult section as applicable.
- **Child Income.** If any children in the household have regular income, such as SSI or part-time jobs, list the total amount of regular incomes received by all children, and check the box for the frequency: weekly, bi-weekly, twice a month, or monthly. Do not include occasional earnings like babysitting or lawn mowing.
- **Adult income.** Report the names of adult household members and income earned in this section.
  - List all adults living in the household not listed in Step 1, whether related or not, such as grandparents, relatives, or friends.
  - **Gross Earnings from Work.** This is usually the money received from working at jobs where a paycheck is received. For each income, check the box to show how often the income is received: weekly, bi-weekly, twice per month, or monthly.
  - List gross incomes before deductions, not take-home pay. Do not list an hourly wage rate. For adults with no income to report, enter a '0' or leave the section blank. For seasonal work, write in the total annual income.
  - **Are you Self-Employed or a Farmer?** List the net income per month or year after business expenses. Do not list the same income twice on the application. A loss from farm or self-employment must be listed as 0 income and does not reduce other income.
  - **Any Other Gross Income.** List gross incomes before deductions from all other sources, such as SSI, unemployment, child support, public assistance, social security, rental income or annuities.

**Step 4: Signature and Contact Information** An adult household member must sign the form. If you do not want your information to be shared with Minnesota Health Care Programs, check the "Don't share" box in Step 4.

**Optional:** Please provide the information on ethnicity and race that is requested on the second page of the form. This information is not required and does not affect approval for school meal benefits. The information helps to ensure we are meeting civil rights requirements and fully serving our community.

The **Richard B. Russell National School Lunch Act** requires the information on this application. You do not have to give the information, but if you do not, we cannot approve your child for free or reduced price meals. You must include the last four digits of the social security number of the adult household member who signs the application. The last four digits of the social security number is not required when you apply on behalf of a foster child or you list a Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF) Program or Food Distribution Program on Indian Reservations (FDPIR) case number or other FDPIR identifier for your child or when you indicate that the adult household member signing the application does not have a social security number. We will use your information to determine if your child is eligible for free or reduced price meals, and for administration and enforcement of the lunch and breakfast programs. We MAY share your eligibility information with education, health, and nutrition programs to help them evaluate, fund, or determine benefits for their programs, auditors for program reviews, and law enforcement officials to help them look into violations of program rules.

At public school districts, each student’s school meal status also is recorded on a statewide computer system used to report student data to MDE as required by state law. MDE uses this information to: (1) Administer state and federal programs, (2) Calculate compensatory revenue for public schools, and (3) Judge the quality of the state’s educational program.
