Standard 1: Academic Achievement

- Super subgroup comprised of students who fall into any of these groups:
 - Black
 - Hispanic
 - Low income
 - Students with disabilities
 - English language learners

Each student is only counted once even if they are in more than one category.

Standard 2: Academic Achievement (super subgroup only)

- 1. Percent of graduates who scored at or above the state standard on any department approved measure of college and career readiness (ACT, SAT, COMPASS, ASVAB) meets or exceeds the state standard or demonstrates required improvement.
- 2. The district's average composite score on any department-approved measure of college and career readiness (ACT, SAT, COMPASS or ASBAB) meets or exceeds the state standard or demonstrates required improvement.
- 3. The percent of graduates who participated in any department approved measure of college and career readiness (ACT, SAT, COMPASS or ASVAB) meets or exceeds the state standard or demonstrates required improvement
- The exam contributing the highest approximate equivalent scores is used for each student

Standard 3: College and Career Readiness -Indicators 1-3

 The percent of graduates who earned a qualifying score on an Advanced Placement (AP) International Baccalaureate (IB) or Technical Skills Attainment (TSA) assessments and/or receive college credit through early college, dual enrollment, or approved dual credit courses meets or exceeds the state standard or demonstrates required improvement.
