Statewide Assessments

SARC Reporting in the 2020-2021 School Year Only

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

Options

Note that the CAAs could only be administered in-person following health and safety requirements. The 2020-21 data cells have N/A values because these data are not comparable to other year data due to the COVID-19 pandemic during the 2020-21 school year. Therefore, the 2020-21 data between school years for the school, district, state are not an accurate comparison. Due to COVID and school closures, Glassbrook operated with strict restrictions due to COVID protocols in the 2021-2022 school year. Although we went back to in-person meetings with parents we struggled with attendance. We have had excellent attendance at Back to School Night and Parent/Teacher conferences, but struggled to maintain attendance at our regular committee meetings. For the 2023-24 school year, we plan on developing a more intentional plan to inquire parent feedback and participation in leadership roles.

Professional Development

As part of our learning path and growth, opportunities for training and staff development are provided at both the district and individual school sites to administrators, teachers, and classified staff. Teachers participate in three full professional development days each year, with an additional half days offered this year to support the small group reading instruction as well as coaching in antiracist pedagogy.

Professional learning opportunities are offered in a variety of forums and settings. Such opportunities are planned by site leaders in collaboration with the Instructional Leadership Team, Woke Kindergarten, an outside consultant with expertise in early childhood literacy, or the Literacy Coach. Woke Kindergarten offered five workshops to teachers as well as weekly coaching opportunities for teachers or teams of teachers. Additionally, a group of teachers was released weekly to dive deep into their approach to literacy. Content and support was differentiated for this release time is planned to be responsive to each teacher's needs.

Teachers and site leaders continued to focus on their own growth as facilitators to continue supporting Glassbrook teachers with the articulation of oa vision and mission.

Content for the site directed half days are determined through site committees such as SBDM, ILT, and School Site Council. The district and school site also offer a variety of professional development opportunities, the topics offered are determined by data from a variety of sources.
