

## **Board Elections (Director District Boundaries)**

**Director District A** – Beginning at the intersection of WCR 100 and WCR 31 near Nunn, CO; thence Easterly along the centerline of WCR 100 to the centerline of WCR 33; thence Northerly along the centerline of WCR 33 to the centerline of WCR 102; thence easterly along the centerline of WCR 102 to the centerline of WCR 51; thence southerly along the centerline of WCR 51 to the centerline of WCR 100 and the east boundary of the Weld County RE-9 School District; thence easterly, northerly, westerly and southerly along said boundary of the Weld County RE-9 School District to the centerline of WCR 102; thence easterly along the centerline of WCR 102 to the centerline of WCR 23; thence southerly along the centerline of WCR 23 to the centerline of WCR 100; thence easterly along the centerline of WCR 100 to the north / south half section line running through the center of Section 30 of Township 9 North, Range 66 West of the 6<sup>th</sup> Principal Meridian; thence northerly along said half section line running through the center of Section 30 to the east / west half section line of said Section 30, in the center of Section 30, as defined by the half section lines; thence easterly along said east / west half section line of Section 30 to the centerline of WCR 27; thence southerly along the centerline of WCR 27 to the centerline of WCR 100; thence easterly along the centerline of WCR 100 to the centerline of WCR 29; thence southerly along the centerline of WCR 29 to the centerline of WCR 98 as extended westerly; thence easterly along said centerline and easterly along the centerline of WCR 98 to the centerline of U.S. Highway 85; thence northerly along the centerline of U.S. Highway 85 to the centerline of E. 4<sup>th</sup> St. in Nunn, CO; thence easterly along the centerline of E. 4<sup>th</sup> St. to the centerline of N. Railroad Ave.; thence northerly along the centerline of N. Railroad Ave. to the centerline of E. 2<sup>nd</sup> St.; thence easterly along the centerline of E. 2<sup>nd</sup> St. to the centerline of WCR 31; thence northerly along the centerline of WCR 31 to the Point of Beginning.

**Director District B** – Beginning at the intersection of WCR 100 and WCR 31 near Nunn, CO; thence easterly along the centerline of WCR 100 to the centerline of WCR 33; thence northerly along the centerline of WCR 33 to the centerline of WCR 102; thence easterly along the centerline of WCR 102 to the centerline of WCR 45; thence southerly along the centerline of WCR 45 to the centerline of WCR 96; thence westerly along the centerline of WCR 96 to the centerline of WCR 33; southerly along the centerline of WCR 33 to the centerline of WCR 94; thence westerly along the centerline of WCR 94 to the centerline of U. S. Hwy. 85; thence southerly along the centerline of U. S. Hwy. 85 to the centerline of WCR 88 near Pierce, CO; thence westerly along the centerline of WCR 88 to the centerline of WCR 31; thence northerly along the centerline of WCR 31 to the centerline of WCR 90; thence westerly along the centerline of WCR 90 to the centerline of WCR 19; thence northerly along the centerline of WCR 19 to the centerline of WCR 102; thence easterly along the centerline of WCR 102 to the centerline of WCR 23; thence southerly along the centerline of WCR 23 to the centerline of WCR 100; thence easterly along the centerline of WCR 100 to the north / south half section line running through the center of Section 30 of Township 9 North, Range 66 West of the 6<sup>th</sup> Principal Meridian; thence northerly along said half section line running through the center of Section 30 to the east / west half section line of said Section 30, in the center of Section 30, as defined by the half section lines; thence easterly along said east / west half section line of Section 30 to the centerline of WCR 27; thence southerly along the centerline of WCR 27 to the centerline of WCR 100; thence easterly along the centerline of

WCR 100 to the centerline of WCR 29; thence southerly along the centerline of WCR 29 to the centerline of WCR 98 as extended westerly; thence easterly along said centerline and easterly along the centerline of WCR 98 to the centerline of U.S. Highway 85; thence northerly along the centerline of U.S. Highway 85 to the centerline of E. 4<sup>th</sup> St. in Nunn, CO; thence easterly along the centerline of E. 4<sup>th</sup> St. to the centerline of N. Railroad Ave.; thence northerly along the centerline of N. Railroad Ave. to the centerline of E. 2<sup>nd</sup> St.; thence easterly along the centerline of E. 2<sup>nd</sup> St. to the centerline of WCR 31; thence northerly along the centerline of WCR 31 to the Point of Beginning.

**Director District C** – Beginning at the intersection of the centerline of U. S. Hwy. 85 with the centerline of WCR 88 near Pierce, CO; thence westerly along the centerline of WCR 88 to the centerline of WCR 31; thence northerly along the centerline of WCR 31 to the centerline of WCR 90; thence westerly along the centerline of WCR 90 to the centerline of WCR 19; thence northerly along the centerline of WCR 19 to the centerline of WCR 102; thence easterly along the centerline of WCR 102 to the western boundary of the Weld County RE-9 School District; thence southerly and easterly along said boundary to the centerline of U. S. Hwy. 85; thence northerly along the centerline of U. S. Hwy. 85 to the south town limits of the Town of Ault, CO; thence westerly, northerly and easterly along the town limits of Ault, CO to the centerline of W. 1<sup>st</sup> St.; thence easterly along the centerline of W. 1<sup>st</sup> St. to the intersection of Alpine Ave. and W. 1<sup>st</sup> St. (also known as CO State Hwy. 14); thence northerly along the centerline of Alpine Ave. to the centerline of W. 5<sup>th</sup> St.; thence easterly along the centerline of W. 5<sup>th</sup> St. to the centerline of Ash Ave.; thence northerly along the centerline of Ash Ave. to the centerline Jackie Ann St.; thence easterly along the centerline of Jackie Ann St. to the centerline of N. 1<sup>st</sup> Ave.; thence northerly along the centerline of N. 1<sup>st</sup> Ave. to the north town limits of Ault, CO; thence easterly along said town limits to the centerline of U. S. Hwy. 85; thence northerly to the Point of Beginning.

**Director District D** – Beginning at the intersection of WCR 33 and WCR 96; thence southerly along the centerline of WCR 33 to the centerline of WCR 94; thence westerly along the centerline of WCR 94 to the centerline of U. S. Hwy. 85; thence southerly along the centerline of U. S. Hwy. 85 to the north town limits of the town of Ault, CO; thence easterly along said town limits to the centerline of N. 3<sup>rd</sup> Ave.; thence southerly along the centerline of N. 3<sup>rd</sup> Ave. to the intersection of N. 3<sup>rd</sup> Ave. and E. 1st St.; thence easterly along the centerline of E. 1<sup>st</sup> St. to the eastern town limits of Ault, CO; thence southerly, easterly, southerly and westerly along the centerline of said town limits to the centerline of U. S. Hwy. 85; thence southerly along the centerline of U. S. Hwy. 85 to the southern boundary of the Weld County RE-9 School District; thence easterly and northerly along said boundary to the centerline of WCR 51; thence northerly along the centerline of WCR 51 to the centerline of WCR 102; thence westerly along the centerline of WCR 102 to the centerline of WCR 45; thence southerly along the centerline of WCR 45 to the centerline of WCR 96; thence westerly along WCR 96 to the Point of Beginning.

**Director District E** – Beginning at the intersection of N. 3<sup>rd</sup> Ave. and E. 4<sup>th</sup> St.; thence southerly along the centerline of N. 3<sup>rd</sup> Ave. to the centerline of E. 1st St.; thence easterly along the centerline of E. 1st St. to the eastern town limits of Ault, CO; thence southerly, easterly, southerly and westerly along the centerline of said town limits to the centerline of U. S. Hwy. 85; thence westerly and northerly along the town limits of Ault, CO to the centerline of W. 1<sup>st</sup> St.; thence easterly along W. 1<sup>st</sup> St. to the intersection of Alpine Ave. and W. 1<sup>st</sup> St. (also known as CO State Hwy. 14); thence northerly along Alpine Ave. to the centerline of W. 5<sup>th</sup> St.; thence easterly along the centerline of W. 5<sup>th</sup> St. to the centerline of Ash Ave.; thence northerly along the centerline of Ash Ave. to the centerline Jackie Ann St.; thence easterly

along the centerline of Jackie Ann St. to the centerline of 1<sup>st</sup> Ave.; thence northerly along the centerline of 1<sup>st</sup> Ave. to the north town limits of Ault, CO; thence easterly along said town limits to the centerline of U. S. Hwy. 85; thence easterly along said north town limits of Ault, CO to the centerline of N. 3<sup>rd</sup> Ave.; thence southerly along the centerline of N. 3<sup>rd</sup> Ave. to the Point of Beginning.
