SIZE RESTRICTIONS

In order to maintain maximum legibility, the district logo should not be smaller than the specifications shown below.

If there is a need for a smaller logo or of the legibility of “Flagler Schools” would be compromised, the lone “Flagler F” may be used.



CLEAR SPACE REQUIREMENTS

Wherever possible, placement of the district and department logos in layout should allow for clear space around the elements of that logo.

Photos and other graphical elements such as type should not overlap or touch the Flagler Schools logo.

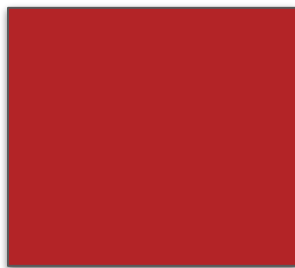


OUR LOGOS AND COLORS

Solid Black/White

For one-color solid black reproduction or routine photocopying purposes.



The full-color logo is the preferred version of our logo and should be used on white ONLY.



The additional options should only be used depending on the layout needs or limitations on reproductions.

Logo Misuses



flaglerschools

Do not substitute colors.
The logo should not be in any color other than the allowable district colors.

Do not switch colors.
The district colors on the logo should never be switched or altered.

Do not screen.
The logo should not be a screen or tint of the original colors.



flaglerschools

Do not distort.
The logo should not be compressed or expanded.



flaglerschools

Do not resize elements.
Size of individual elements should not be altered.



Do not rotate.
The logo should never be rotated.



Do not place on photos.
The logo should not be placed over a photograph or patterned background in which it is obscured.



Do not add elements.
Clip art or other elements should not be added to any part of the logo.
