The Board of School Trustees of Fort Wayne Community Schools will meet in Executive Session on **Thursday, July 13, 2023, 9:30 a.m.**, at Renaissance Pointe YMCA, 2323 Bowser Ave, Fort Wayne, IN 46803 for the following purpose/s in accordance with I.C. 5-14-1.5-6.1:

_____ Where authorized by federal or state statute.

For discussion of strategy with respect to:

- _____ (A) collective bargaining;
- _____ (B) initiation of litigation or litigation which is either pending or has been threatened specifically in writing;
- _____ (C) the implementation of security systems; or
- _____ (D) the purchase or lease of real property of the governing body up to the time a contract or option to purchase or lease is executed by the parties.
- _____ (E) School consolidation.

However, all such strategy discussions must be necessary for competitive or bargaining reasons and may not include competitive or bargaining adversaries.

_____ For discussion of the assessment, design, and implementation of school safety and security measures, plans, and systems.

However, this subdivision does not apply to any discussions regarding research that is prohibited under IC 16-34.5-1-2 or under any other law.

_____ To receive information about and interview prospective employees.

With respect to any individual over whom the governing body has jurisdiction:

- _____ (A) to receive information concerning the individual's alleged misconduct; and
- _____ (B) to discuss, before a determination, that individual's status as an employee, student, or independent contractor who is a physician or school bus driver.

_____ For discussion of records classified as confidential by state or federal statute.

_____ To discuss before a placement decision an individual student's abilities, past performance, behavior, and needs.

 X To discuss a job performance evaluation of individual employees. This subdivision does not apply to any discussion of the salary, compensation, or benefits of employees during a budget process.

- _____ (B) consider applications; and
- _____ (C) make one (1) initial exclusion of prospective appointees from further consideration.

_____ To train school board members with an outside consultant about the performance of their role as public officials.

For discussion by the governing body of a state educational institution of:

- _____ (A) the assessment of; or
- _____ (B) negotiation with another entity concerning;

the establishment of a collaborative relationship or venture to advance the research, engagement, or education mission of the state educational institution. However, this subdivision does not apply to any discussions regarding research that is prohibited under IC 16-34.5-1-2 or under any other law.
