



## Superintendent's Message



Dear LCS Families, This year the pandemic has forced us into changes in daily life many of us have never encountered. We have accomplished some amazing things despite this world wide crisis.

- All of our students who chose in-person instruction attended school 5 days/week starting in September (we also offered remote instruction)
- We provided free daily meals to all of our students
- We were able to slowly implement athletics and certain arts opportunities back into our school environment
- We have been able to mitigate any large outbreaks of COVID-19 at school, due to an adherence to CDC protocols and diligent cleaning procedures.

This has been a TEAM effort from the onset of this journey. The Letchworth community, staff, students and local Department of Health continue to work collaboratively, patiently, and thoughtfully, demonstrating grace and empathy as we handle frequently changing guidelines.

We are pleased that we can propose a 2021-22 LCS school budget to our community that has a 0% increase in the tax levy. Over the past four years we have been able to offer high quality programs and opportunities to our students at a 0% increase three out of four years. We need to understand that this may be a trend that is not sustainable long term, but is very helpful to our community and our residents when we can ease any budget increases locally.

On the financial front here at school, we went from a very bleak state aid projection to one that resulted in a 3% increase over last year. Last year, we took a stance to cut nearly 8% from our operating costs to be sure that we did not put ourselves in a deficit this year, anticipating an economic downturn. Recent changes in Albany and at the federal level have produced an increase in funding for local schools. I would like to briefly explain how this funding will help us here at LCS and what limits we have to use it, based on the information I have at this time.

- Federal stimulus, recovery and relief funding isn't here yet. A portion of the funding from the first of three federal relief bills have arrived. Eligible use of the funds hasn't been clarified by Albany or at the federal level. There's no application for these funds and little to any guidance as of today. The federal money is a "one shot" revenue. It has a time period during which it can be used and restrictions on how it can be used. Districts that use federal funding to begin programs that have long term implications are not recommended. Sure, there are lots of good uses for those funds but prudent planning is needed. We do not want to add and then eliminate programs and services based on one time assistance.
- State aid funding did see a slight increase. This
  assisted in handling our climbing cost of doing
  business with areas of increases in contractual
  needs, transportation, and health care costs.

Planning, designing and programming for our newly approved Capital Improvement Project is ongoing and on schedule. We are hopeful to go out to bid on the capital project in the winter of 2022 and break ground on the new project in the Spring of 2022. We included in the proposed 2021-22 budget to build a new AG barn that will enhance our programming and provide a much needed updated space for our Ag and Technology classes. All of these upgrades will continue a long standing tradition of excellence and commitment, to keep our students competitive and well trained, as they leave our doors to pursue careers or higher education.

We are optimistic about our future here at LCS. We have a staff that is enthusiastic, committed and professional. Our students strive hard each day and our community remains supportive both financially and emotionally. We are proud of Letchworth and realize it is a very special place to learn and live.

# Please vote on Tuesday, May 18 from Noon to 9 p.m.

This year has produced the "best" in the people of our small, rural school. I have never doubted, TOGETHER...WE are Letchworth!



## The School Budget and the New York State Tax Levy Limit (Tax Cap)

New York State has instituted a tax levy limit, commonly referred to as a "cap", that provides a state formula to establish a levy limit that determines if a simple majority or a super (60%) majority will be required for passage. The levy limit for Letchworth this year was calculated to be 3.52%. Since the proposed levy amount for this year is 0.0% (or \$161,453 below the cap), a simple majority will be required for passage.

### Tax Levy


The proposed expenditure plan of \$21,715,217 is partially funded by a tax levy of \$4,583,021. This is a <u>0 percent increase in the levy from last year.</u> To calculate the tax rate for each of the nine towns within the District, both the assessed values and the equalization rates are used. Final assessments and equalization rates will not be available until August. The graph to the right displays historical information on the true value tax rate in the district with a projected rate for 2021-22. Under this proposed budget the tax rate on true value is estimated to remain the same at \$12.85 per thousand.

#### PROPOSED ANNUAL SCHOOL BUDGET FOR 2021-2022

## **Proposition 1 - Budget \$21,715,217**

The Board of Education of the Letchworth Central School District shall be authorized to expend the sum set forth in the proposed budget for the 2021-22 school year in the amount of \$21,715,217 and to levy the necessary tax therefore.

## Proposition 2 - Equipment Purchase from Maintenance Vehicles/Equipment Reserve

Be it resolved that the Board of Education of the Letchworth Central School District shall be authorized to expend funds from the 2015 Maintenance Vehicles/Equipment Reserve Fund, established by the voters on May 19, 2015 under Section 3651 of Education Law, for the purchase of one (1) area mower and one (1) tow-behind mower; not to exceed the total sum of \$95,000.00.

## **Proposition 3 - Library Funding** (as received from the libraries)

Shall the amount of funds raised by taxation to support the four public libraries in the Letchworth Central School District be increased from \$205,909.89 to \$208,442.58 the increased amount to be distributed as followed: \$33,350.98 to the Eagle Free Library, Bliss; \$70,869.80 to the Cordelia A. Greene Library, Castile; \$62,533.08 to the Gainesville Public Library, Silver Springs; and \$41,688.72 to the Pike Library Association, Pike?

Qualifications of a voter: ♦United States Citizen ♦Eighteen years of age or older ♦Resident of the School District for 30 days prior to voting

**ABSENTEE BALLOTS** The option of using an absentee ballot is available for the school district annual budget vote. To obtain an absentee ballot, you must be a qualified voter of the school district and be unable to personally appear to vote. One of the following qualifications must apply:

- a) a patient in a hospital, or unable due to illness or physical disability;
- b) out of town because of duties, occupation, business or studies you must provide a description of duties or special circumstances:
- c) on vacation outside the district you must provide dates of beginning & ending of vacation, where you will be, name & address of employer, or statement of self-employment, or a statement of retirement;
- d) in jail affidavit must state if detained awaiting action of grand jury or confined after conviction for a non-felony. Qualified voter spouse, parent, or child is also entitled to vote as absentee if expected to be absent from the district accompanying an absentee ballot applicant upon personally making and signing an application based on the above reasons.

The application must be received by the clerk at least 7 days before the election if the ballot is to be mailed to the voter, or the day before the election if it is to be delivered personally to the voter. All completed absentee ballots must be received no later than 5:00 PM on the day of the election. (Tuesday, May 18, 2021)

Qualified voters may pick up applications at the District Office at Letchworth Central School during regular business hours. You may request an application be sent to you by contacting the District Clerk, in writing at 5550 School Rd., Gainesville, NY 14066, or by phone at 493-5450.

#### PUBLIC HEARING


#### Monday, May 10, 2021 @ 7:30 PM

The growth socially, academically, physically, and emotionally for our students is well documented through changes in behavior, work completion, assessment scores, new friendships, and the smiles, high fives and chatter we hear and see each day.

This speaks loudly for the commitment of our amazing faculty and staff, the determination of our students, and the support of families and community members. I am proud to be a member of the Letchworth community and gratefully share the successes of our precious students with you.
