
Yet, if there is anything to be learned from this

Please be sure that you vote. Every vote matters! All ballots must be received by the District Clerk by 5 PM on June 9, 2020.

In conclusion, I want to congratulate our Seniors and families on all of their accomplishments. Each week we have recognized our Seniors in special ways with yard signs, goodie bags, personal notes and social media blasts! We are so proud of the way they have handled this disruption with maturity and a grateful spirit.



THE SCHOOL BUDGET AND THE NEW YORK STATE TAX LEVY LIMIT (TAX CAP)

New York State has instituted a tax levy limit, commonly referred to as a "cap", that provides a state formula to establish a levy limit that determines if a simple majority or a super (60%) majority will be required for passage. The levy limit for Letchworth this year was calculated to be 4.00%. Since the proposed levy amount for this year is 0.0% (or \$183,239 below the cap), a simple majority will be required for passage.


Tax Levy

The proposed expenditure plan of \$21,013,669 is partially funded by a tax levy of \$4,583,021. This is a 0 percent increase in the levy from last year. To calculate the tax rate for each of the nine towns within the District, both the assessed values and the equalization rates are used. Final assessments and equalization rates will not be available until August. The graph to the right displays historical information on the true value tax rate in the district with a projected rate for 2020-21. Under this proposed budget the tax rate on true value is estimated to increase to \$13.81 per thousand.

VOTE & ELECT BOARD MEMBERS

Pursuant to the Governor's Executive Order 202.26, the annual budget vote and school board election has been scheduled for June 9, 2020, and will be held by absentee ballot only.

Qualified voters of the Letchworth Central School District will be sent an absentee ballot together with a postage-paid return envelope and instructions for completing the same. Absentee ballots will be mailed to the following: •District residents listed on the Letchworth Central School Tax Roll List of property owners, •District residents listed on the Wyoming County Board of Elections List of Registered Voters, •District residents listed on the Letchworth Central School list of students 18 years old or older and •District residents listed on the 2019-20 Budget Vote & Election Poll List.

Qualified voters that do not receive their absentee ballot may request a ballot by contacting the District Clerk by email at tlathan@letchworth.k12.ny.us or by calling the District Office at 585-493-5450.

To be counted, all completed absentee ballots must be received in the Office of the District Clerk by 5:00 p.m. on June 9, 2020.

PROPOSED ANNUAL SCHOOL BUDGET FOR 2020-2021

Proposition 1 - Budget \$21,013,669

The Board of Education of Letchworth Central School shall be authorized to expend the sum set forth in the proposed budget for the 2020-21 school year in the amount of \$21,013,669 and to levy the necessary tax therefore.

Proposition 2 - Library Funding (As received from the libraries)

Shall the amount of funds raised by taxation to support the four public libraries in the Letchworth Central School District be increased from \$202,249.18 to \$205,909.89, the increased amount to be distributed as followed: \$32,945.75 to the Eagle Free Library, Bliss; \$70,008.69 to the Cordelia A. Greene Library, Castile; \$61,773.27 to the Gainesville Public Library, Silver Springs; and \$41,182.18 to the Pike Library Association, Pike?
