#### Mental Health & Wellness

Head Start used the services of our Behavioral Therapist to provide services for children and families. In 2021-2022 School Year we will be transitioning to McNeil Family Counseling Services to provide services to children and families. One on one intensive services are available as needed.

All children enrolled in the Head Start program received wellness instruction through the daily lesson activity plan, Conscious Discipline, Stanford Harmony, and the opportunity to participate in music & art.

### Dental Care & IEP's

Dental care is essential for good health. Of 107 children, 104 had continuous, accessible dental care from a dentist upon enrollment. At the end of the year 106 children received preventive care and a dental examination. 13 out of 16 children who needed dental treatment received it before the end of the school year. Head Start uses the services of the Alexander County Dental Clinic. In addition, during the pandemic, we were able to partner with the Colgate Dental Bus to offer a virtual visit, a virtual parent workshop and send dental supplies to children and families.

Head Start Served 29.63% or 32 children with an Individualized **E**ducation **P**lan or IEP. Of the 32, 75% (24) entered the program with am IEP in place. 8 children were identified as needing an IEP after they enrolled the program.
