Students in the Council Rock School District are issued a mobile electronic device for their educational use (Board Policy 816). This device is and remains the property of the Council Rock School District and is not to be used other than for educational purposes relating to the receipt of educational programming. If reasonable precautions and care are taken in the use of the device, the device should not experience physical damage. **Each student and their parent or guardian is asked to read this form carefully.** The parent/guardian and the student should initial next to each statement that follows, and sign at the bottom of this document.

By completing this form, you are indicating that you understand that:

- Teachers MAY choose to record live streaming sessions for playback by students who are unable to attend, which may occasionally include student voices– however – teachers will generally endeavor not to record students’ faces and these sessions will typically be deleted by the teacher within three (3) days of recording and will no longer be accessible;
- the District may remotely access a student’s computer to update the software and make system changes as needed;
- both teachers and other technology employees of the District may remotely monitor a student’s use of the Chromebook to see what work a student is doing and to track and report on the machine’s use and browser history;
- while the District cannot activate the internal computer camera or audio to see or hear a student, a District employee may deactivate the ability of the student to use the computer’s internal video or audio system if it is suspected that either is being used inappropriately;

Failure of students and/or parents or guardians, or others in their household or control, to comply with the following statements shall result in usage restrictions, loss of access privileges, disciplinary action, and/or legal proceedings.

I/We understand that live video or audio sessions in which the student is participating as part of the educational program may NOT be recorded, photographed, altered or otherwise captured or reproduced on any device for any reason.

I/We understand that screen capture or recording in any form of any interactive livestreaming video or audio content is NOT permitted.		
I/We understand that any live or recorded lessons may NOT be altered and used outside of the classroom setting or for any purpose other than participation in the classroom.		
I/We understand that the device (Chromebook) and its accessory equipment are the property of Council Rock School District.		
I/We understand that the student, with the support of the parent or guardian, is responsible for the daily care and maintenance of the device and its accessories.		
I/We understand and agree to abide by the rules and regulations of the Acceptable Use Policy 815; the District Mobile Device Policy 816; and the Livestream Video Policy 817.		
I/We understand that I/we must report all device damages, or the theft/loss of the device to school administration.		
I/We understand that, unless instructed otherwise by a teacher, all students must have their device with them each day for every class.		
I/We understand that if the student did not exercise proper care and/or take appropriate precautions, and this behavior resulted in damage to the laptop, the cost of the repair will be the responsibility of the student/parent or guardian, and may also result in disciplinary action against a student.		
I/We will not install or add any programs, extensions or software.		
I/We understand that the device and its accessory equipment will be returned at the end of the school year.		
I/We will not attempt to circumnavigate the security of the device, nor attempt to make any modifications to its configuration.		
I/We understand that the device may not be altered or personalized in any manner, and that I/we may not decorate it with markers, stickers, or modify its appearance in any other way.
