MESSAGE FROM THE SUPERINTENDENT

Dear Letchworth Central School District Community Members,

On May 16, 2017 the Letchworth Central School District is bringing a capital project to vote. The desire to provide our students a meaningful educational experience combined with a pressing demand to maintain facility and program standards helped shape the scope of work included in the capital project. Past success in meeting the needs of our children is a direct result of thoughtful and measured improvements. In order to continue on a successful path and protect past investments, we've carefully examined a recently completed building condition survey and the needs of a 21st century learner.

These two factors were able to provide us a clear focus of priority work to present within the project. In the case of our facility needs, replacing items that have succumbed to normal wear and tear, such as roof and window replacements, throughout a majority of the district have been included. Other projects are designed to support and enhance current programs such as the renovation of science labs and classrooms in the 1955 portion of the building and athletic track improvements.

The capital project will cost \$11,724,200 and through much preparation there is already a plan set in place to pay for this project. The result is that this project will require NO ADDITIONAL TAXES to the taxpayers in our district. There will be a public meeting on Monday, May 8, 2017 at 7:30 PM in the Learning Center. This meeting will include a presentation of the details of the proposed project with a question and answer session to follow.

We encourage all district residents to attend the informational presentation to learn the specifics of this proposed capital project and what it can do for our children and community.


