## Statement of Purpose

Annette Perry Elementary fosters an atmosphere of academic achievement and community pride. Through collaborative efforts of staff members, parents, and students we will increase the academic success of all students.

## Goals

## Parent and Family Engagement Policy

Annette Perry Elementary will provide parents with a copy of the Parent and Family Engagement Policy via the school website. Parents will have the opportunity to address and revise any concerns they may have through a variety of ways, such as PTA meetings, site-based meetings, Perks with the Principal, and parent surveys.

## Annual Parent Meeting

Annette Perry Elementary will hold an annual fall and spring meeting (Perks with the Principal) for all parents of participating children (Option 1 in the morning and option 2 Virtual.) Parents will be notified of the meeting through a notice posted to the school website, Facebook, Twitter, Class Dojo, and email.

At the annual Title I meeting (held during Grade Level Orientation night at the beginning of the year), we will present general information about the Title I program, the curriculum, instruction, and various forms of assessment used to measure student progress. Parents will also be given information about the school's programs, and specific curriculum information in the following subjects: math; language arts; science; social studies; and enrichment. Parents will also be given information about how to schedule parent-teacher conferences, student interventions offered for struggling students, and opportunities to become involved in campus activities.

## Annual Parent Survey

- Based on the feedback provided at the end of the school year by the parent survey, the Perry Campus Improvement Committee will review, evaluate, and revise the parent involvement plan, campus interventions and programs, and parent communication methods.
