## Waterford Oaks School Parental Involvement Policy

### PART I. GENERAL EXPECTATIONS

**Waterford Oaks Elementary School** agrees to implement the following statutory requirements:

7. **Waterford Oaks Elementary School** will provide assistance to parents, as appropriate, in understanding topics such as the State's academic content standards and student academic achievement standards, State and local academic assessments, how to monitor a child's progress, and how to work with educators to improve the achievement of their children. 8. **Waterford Oaks Elementary School** will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

9. **Waterford Oaks Elementary School** will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to,
