Dear Parent/Guardian,

The Warren Hills Regional Board of Education has implemented a voluntary random drug testing program for middle school students. This program is designed to deter drug and alcohol use, to provide students with a way to combat peer pressure, and to help us identify students who are using drugs and/or alcohol so that they can receive the help they need. This is not a punitive program. We encourage all our students to participate.

The voluntary testing program began for 'athletes only' during the 1998-99 school year. We then broadened the scope of the program to include any student, not just athletes, who would like to be a part of the random testing pool. In 2006, the Board of Education adopted a mandatory random drug testing program for high school students involved in extracurricular activities, athletics, and on-campus parking. The expansion of the middle school voluntary program to include all students allows us to more closely model the mandatory program at the high school.

Students who volunteer to be tested will be selected randomly by a computer program. Approximately 10% of the students in the random testing pool will be tested during the school year in this specific program. A urine specimen will be collected in accordance with Federal Substance Abuse and Mental Health Services Administration standards and an on-site test will be conducted. Students with a confirmed positive test will be removed from any extracurricular activity they are participating in for a period of time in keeping with the present Warren Hills drug and alcohol policy and receive counseling or treatment as indicated. Student's test results will be treated as a confidential health record pursuant to both federal and state regulations.

Please return the 'Consent to Test' form by September 30th whether or not you elect for your child to participate.
