



September 11 Events

On September 11, two important events will occur concurrently on the Clinton Central School campus. The Edward Porter Felt Flight 93 Memorial Project, whose mission is to establish and maintain a memorial to honor Edward Porter Felt, a Clinton native and hero of United Flight 93, will hold a dedication ceremony beginning at 1p.m. at the monument site. Immediately following, 56 bricks will be dedicated at the Brick Garden Ceremony, the first to be held in three years. The Garden dates back to 1993 when it was built to symbolize the

Capital Project Planned

With the final phase of the 2018 Capital Project completed during the summer months, the District has initiated the planning process for the next project in accordance with the Five-Year Capital Plan. Over the course of spring 2022, CCS staff members, architects and financial advisors have worked to establish the proposed scope and budget of the project which will include improvements to libraries, athletic fields, the elementary kitchen, the middle school roof and other miscellaneous items.

The special voter referendum will take place on Tuesday, December 13, from noon to 8:00 p.m. in the theater lobby. School Lunch Program

The Clinton Central School Food Service staff is looking forward to welcoming your children back to school.



We understand the role of good nutrition in our students' scholastic, athletic and extra-curricular activities and promote school lunch as an important ingredient of their success. School Weather Emergency Closings

The decision to close schools because of adverse weather conditions is not made lightly or easily. The road conditions in the District are reviewed by district and town staff, and the final decision is made by the Superintendent after consulting with the town and surrounding school districts.

A text and/or email will go out on ParentSquare to the phone number provided to the building offices alerting parents of closings or delays. Local media are informed and information is posted on the website at www.ccs.edu.

ParentSquare is the most commonly used communication tool for district and building notices. Please make sure that your student's building office has your most current contact information on file so that you receive these important communications!

Dignity for All Students Act

No student may act toward another student in a way that might reasonably make them feel threatened or unsafe, or that might reasonably make them unable to concentrate on their schoolwork because of what you might think about their race, color, weight, national origin (where their family comes from), ethnic group, religion, religious practice, disability, sexual orientation, gender (including gender identity or expression), or sex, or for any other reason. It is against school rules for any student or staff member to do this by physical actions or by verbal statements, including electronic messages. This kind of behavior is prohibited on school property, on school buses, and at all school-sponsored events

How Do I Sign Up?!



CCS uses FamilyID to enroll students in athletic programs. For each sports season, information will be shared on Parent Square with the FamilyID link provided. Asbestos Hazard Emergency Response

In accordance with the Asbestos Hazard Emergency Act of 1987 (AHERA), and CCS Policy #7100, a copy of building inspection reports are available for review by appointment. CCS Policy #7365 ensures that all areas disturbed through renovation or demolition are tested for lead and asbestos.

Use of Pesticides

The District recognizes that pests can pose a significant risk to health and property, and that significant risks exist in using chemical pesticides in the school environment. In accordance with CCS Policy #8115, pesticides will not be used on District playgrounds, turf, athletic or playing fields unless an emergency occurs, which will be handled in accordance with applicable law and regulation. In the event that this becomes necessary, all District staff and parent/guardians will be notified.

Code of Conduct
