Dear Clinton Community,

I hope that this message finds you well and that you are enjoying the warmer and longer days of spring. This is an exciting time of year as we begin to prepare for the end of the school year. The months of May and June are packed with events, activities and ceremonies that celebrate the incredible accomplishments of our community's children. This edition of our newsletter is full of information about our district and students. It also provides detailed information about the proposed 2023-2024 budget. We invite you to read about the awards, achievements and initiatives that reflect the strong, well-rounded program that Clinton Central School District has established.

The public Budget Hearing will be held on Tuesday, May 9, 2023 at 6:30 p.m. in the Theater. This will be an opportunity for the community to learn more about the 2023-2024 budget and spending plan. Candidates who are seeking election to the Board of Education will participate in a forum at 5:30 p.m. on the same evening in the Theater. Please consider attending both events so that you can make an informed decision when you vote. The Budget Vote and Board of Education Election will be held on Tuesday, May 16, 2023 from noon to 8 p.m. in the Theater Lobby.

CLINTON STUDENTS RECOGNIZED IN

CHINESE LANGUAGE ESSAY CONTEST



Clinton sixth grade student Emily Chen and seventh grade student Alexandra Allen recently received gold awards in the Chinese Language Association of Secondary-Elementary Schools (CLASS) National Essay Contest.

Chen and Allen currently study Mandarin Chinese through the Oneida-Herkimer-Madison BOCES Interactive Video Courses (IVC) program and were among 650 students studying the Chinese language and culture nationwide who participated in this year's contest. For the middle school essay contest, students were asked to think about the things that the adults in charge are doing well and not so well, and what they would do differently if they were an adult with the power to change things. In the essay, Allen mentioned that if she were president, she would work on four things: gun control, helping homeless people, stopping discrimination and reducing the payment for health care. Chen wrote about how she would have behaved differently during the pandemic; giving more attention to those who can't access medical treatment or have a lack of food at home.

The competition aims to promote the study of the Chinese language and culture among students in the United States and to foster greater cross-cultural understanding. Their success is a testament to the hard work of teachers as well as the support from each school in promoting the study of the Chinese language and culture.

Clinton Schools FOR A GREENER FUTURE

Throughout the past several years, Clinton students have been a part of the change to create a greener school and district. At the High School, students in the Leaders in Environmental Awareness and Protection (LEAP) Club have initiated changes such as recycling thin film plastic and collecting and recycling toiletry products. A partnership with the

Oneida-Herkimer-Madison BOCES Food Service has also enabled further waste reduction in the cafeteria through the use of paper straws and the planned implementation of reusable trays and cutlery. Lastly, students have requested the transition to composting for the cafeteria, which the District hopes to provide in the future.

Another positive change in the effort to reduce energy and waste are the signs that students have posted throughout the district reminding teachers and staff to conserve paper when using printers and copiers. These signs ask teachers to be mindful about their printing settings and to consider whether students need hard copies of the item or if it could be posted digitally instead.

At the Elementary School, a Green Team consisting of 30-40 students from the fourth and fifthgrades existed during the 2017-2020 school years. Working with the Oneida-Herkimer Solid Waste Authority, students participated in the Zero Waste Lunch and Plastic Film Challenges. Students learned about recycling, how to reduce waste and then educated the school community through posters and morning announcements. Elementary students also celebrated Earth Day and planted a garden behind the school.

The District's goal is to reduce its carbon footprint while making strides to inspire others to do the same and help drive a significant change. When students have a great idea to improve the culture and climate of their school and environment, Clinton is proud to support them and help foster their initiative.

- The Writing Revolution

In fall 2020, Clinton Middle School implemented The Writing Revolution (TWR), a consistent, multi-grade level framework aimed at enabling all students to become proficient writers, readers and critical thinkers.

"Before the implementation of TWR, each teacher worked individually to achieve increased writing proficiency," said Sarah Gaetano, middle school English teacher. "What was challenging were the different styles and methods that each teacher brought to the students."

Since transitioning to TWR, teachers are now more consistent with writing-related vocabulary in all of their content areas and students come to class with prior, consistent knowledge that can be concentrated on the material, reading comprehension and communication.

To increase student achievement and address educational gaps, TWR allows for the use of writing examples for the students to model and additional criteria for both students and teachers to meet, while continuing to align with state standards. TWR has impacted students through its framework for teaching writing that emphasizes the explicit instruction of the structure and mechanics of writing. This improves students' writing skills by teaching them to write in an organized and concise manner, while using clear and precise language. Using outlines, transition words and subordinating conjunctions to show connections between thoughts and relationships, students develop their critical thinking skills as they learn to organize and express their thoughts in a logical and coherent way.

After three years, the shift in framework brought about by TWR has had a positive impact on students across all grade levels. CCS expects that students' writing skills will continue to improve and this will impact their critical thinking, allowing them to communicate more effectively, write persuasively and better evaluate information and literature.





CLINTON CENTRAL SCHOOL DISTRICT - BUDGET INFORMATION

PROPOSITION 1

Resolved, that the Board of Education of the Clinton Central School District, Oneida County, New York, is hereby authorized to expend and there is hereby appropriated, the sum of \$30,777,153 estimated by it to be necessary for school purposes for the fiscal year commencing July 1, 2023 and to raise so much thereof as may be necessary by tax on the taxable property in said School District.

PROPOSITION 2

Shall the sum of \$337,905 be raised by annual levy of a tax upon the taxable property within the Clinton Central School District for the purpose of funding the Kirkland Town Library?

Library tax is <u>not</u> school tax and is not part of the school district budget. When a school district is approached by a library regarding tax levies, the district does not have a choice with respect to whether to present the proposition to voters. Under Education Law section 259, a BOE must submit a library appropriation to voters if requested by a library's board of trustees. ACCOUNTABILITY UPDATE

The Every Student Succeeds Act (ESSA), the main federal law for K-12 public education, aims to ensure all children get a quality education. The law requires that states hold public schools accountable for how students achieve.

Clinton Central School District is pleased to share that the New York State Education Department (NYSED) has upgraded its previous designation of Clinton Middle School from a school identified for Targeted Support and Improvement (TSI) to a Local Support and Improvement (LSI) school. The designation of LSI is the highest accountability status currently available and aims to recognize that all schools, even higher performing schools, are continuously improving and can benefit from local support from their districts to meet students' differentiated needs. As a byproduct of the improvements made, the Clinton CSD has also been identified as a LSI District for the 2022-23 school year. Throughout the past three years, the District was involved in a collaborative effort with stakeholders to develop and implement several school and Districtwide improvement and educational plans. The feedback and support received from families, students, teachers, administrators and other educational experts was critically important to the development of the plans used to make educational improvements for students across the District. The LSI designation could not have been achieved without these partnerships and without the hard work and dedication from our staff.



CCSD Tech Update

Beginning in fall 2023, the Clinton Central School District will transition to a 1:1 instructional technology integration model. A 1:1 model ensures that students in identified grade levels will receive a District-assigned Chromebook as an instructional resource to be used at school and home. Although we live in an era when technology is seemingly ubiquitous, we recognize that we do have students who do not have regular, equitable access to devices when they are not in school. As we continue to update our students' learning tasks and experiences at school, we need to be sure that we are providing them with the right tools to extend their learning beyond the school day.

This progression in instructional model will provide for equity of all learners, as well as aligned and relevant instructional practices across grade levels and school buildings. With the ability to continue learning beyond the walls of the traditional school building, student device access can increase engagement and quality of learning, all while providing students with digital citizenship skills that can better equip them for our modern world.

In anticipation of the fall launch, the District will continue discussing and developing plans relating to the ways in which the 1:1 model will be embedded into the culture of the Clinton Central School District and become a regular part of the student-learning process. In the coming months, more details will be shared with students and families about device management, distribution and use.
