#### The Antidote

Although there have long been opinions on the negative impacts of increased screen time and unmonitored gaming and social media use among children, we are now learning about the results of some longitudinal studies. These studies do find a correlation between the amount of screen time and increased symptoms of OCD, ADHD, poor self image, lagging social skills and the inability to regulate emotions effectively. In the education world, students with lagging social skills and difficulty regulating emotions lead to increased negative behaviors and negative impacts on academic achievement.

We are proactively working to counter these negative outcomes with two known and impactful antidotes we have at hand: Nature and Play. There are equally as many studies that show getting a nature fix and actively participating in creative play have a positive impact on students' (and adults too!) well being.

This year, we participated in the Global Day of Play and had an overwhelmingly positive response from students about the experience.

We are investing in new

playgrounds: One for the Elementary

Building and one for the Middle School Building. Our students will actually have the opportunity to VOTE on some of the equipment for these new playgrounds during our Annual Budget Vote this year, so keep an eye out for details.

We have also convened our Woods Development Committee to explore ways to increase access and use of the 50 acres we have adjacent to the Middle and Elementary buildings. We are excited to have woods and

trails right here for our students to explore! (See possible new features on page 2.)
We continue to offer a wide variety of activities and clubs for students in all grades. From Odyssey of the Mind, to Cooking Club, Travel Club, Bee Club, Technology Club and more — there is ample opportunity for students to engage with each other OFF SCREEN doing things they enjoy.

Our families and community can help by continuing to find ways to engage students in play and interacting with nature. We have so many wonderful local resources — the public library, the town parks and local preserves. #### **BUILDING HIGHLIGHTS**

#### **ELEMENTARY SCHOOL**

We continue to focus on our PRIDE behaviors and school-wide community here at the elementary school. Our PRIDE tree continues to grow every day as students earn a PRIDE Pal. Our Tier 1 team has done a great job planning for school-wide PRIDE activities including Spirit Weeks and Global Play Day.

Students continue to grow as learners as they participate in a variety of learning opportunities on a daily basis. Literacy is a focus here in the building as students develop their reading skills in small groups, the large group classroom setting, independently and on special occasions. The first grade class recently celebrated Read Across America Day by dressing as their favorite book character!

#### MIDDLE SCHOOL

The Middle School students are finishing up another successful year. Students were given opportunities to participate in multiple building wide events including: Global Play Day; Cultures Around the World Day; PRIDE quizzes competition; Mega Playground Day; Mega Arts Day; and Field Days, which is coming up in June.

Students have shown academic and social growth throughout the year as well. Students have completed our NYS ELA and Math Assessments and our last i-Ready benchmark will be given at the end of the school year. Our goal has been — and continues to be — to give students opportunities socially and academically in a safe environment. We work on our PRIDE attributes every day.

#### HIGH SCHOOL

In March our Drama Club put on "Evita," which was a huge success. Prom this year is at Blue Heron Hills on April 29 and the theme this year is Lanterns on the Lake. Our winter athletic season has also ended, with a section win for our girls indoor track team and multiple accolades for individual athletes.

We continue to keep our PRIDE expectations high, with weekly lessons in Forum and opportunities to catch students doing the right thing. Recently, we celebrated Pi Day (3/14) with staff volunteers taking a pie to the face courtesy of lucky PRIDE ticket holders.

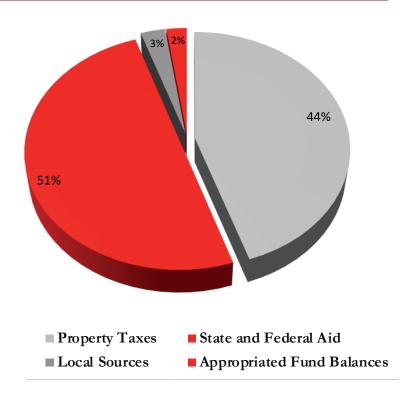
#### **FUNDING SOURCES**

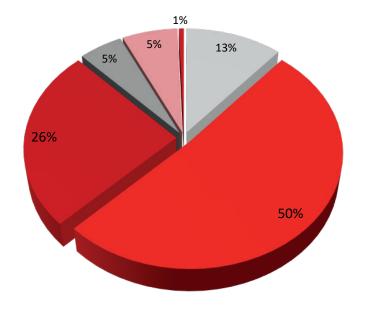
STATE AND FEDERAL AID - This category includes NYS foundation (basic) aid, as well as categorical expense based aids to support BOCES services, debt service from capital projects, transportation costs, and instructional materials. The District also receives federal reimbursement for eligible Medicaid services.

REAL PROPERTY TAX – This category includes the local property tax levy as well as Payments in Lieu of Taxes (PILOTS) under industrial development agreements.

LOCAL SOURCES – This category includes Williamson's allocated share of sales tax from Wayne County, interest earned on the District reserves and cash on hand, and other miscellaneous refunds and fees for services.

FUND BALANCE AND RESERVE – This category includes the utilization of surplus funds from the prior year's budget as well as debt service reserves to reduce taxes. The District also appropriates funds from several reserves to defray costs of certain employee benefits and insurances.

#### **EXPENDITURES**

INSTRUCTION – This category includes teacher's salaries, student support services, instructional technology and curriculum coordination, instructional materials, BOCES instructional programs, co-curricular and extra-curricular programs.

**GENERAL SUPPORT** – This category includes maintenance of buildings, grounds, and infrastructure, utility costs, central administration for human resources and finance, and costs related to legal support, compliance, and governance.

TRANSPORTATION – This category includes the operational costs for transportation of students to District schools, parochial and private schools, BOCES programs, field trips, and extra-curricular events.

EMPLOYEE BENEFITS – This category includes the cost of social security, NYS retirement systems, health insurance, worker's compensation and unemployment insurances. Insurance premiums and retirement system contributions are the most difficult area of the budget to control cost growth.

DEBT SERVICE AND INTERFUND TRANSFERS – This category includes debt service from capital projects, which is supported by associated state building aid, as well as support of the school's food service and special education programs.

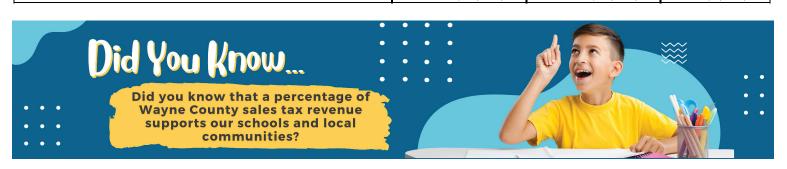

finance experience while simultaneously learning about both the small business environment in New York and the agriculture industry.

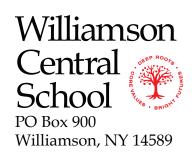

## Proposition #1 Budget

What: Shall the proposed school budget for the period July 1, 2023 to June 30, 2024 in the amount of \$27,075,900 be approved?

*Why:* This is the voter approval necessary for the District's annual operating budget. If defeated, a second vote would be held in June with the potential of implementing a contingency budget that would remove certain programs and services.

### **Proposition #2**Bus Purchase

What: Shall the Board of Education of the Williamson Central School District hereby be authorized to purchase three (3) 65-passenger school buses and one (1) 24-passenger school bus for the purpose of providing student transportation, including original equipment and incidental expenses for the foregoing purpose, at a total estimated cost after taking into account state aid and trade-in value and rebate not to exceed \$538,164.22; and that such sum or so much thereof as the Board may deem appropriate, in its discretion, shall be paid from the 2019 Bus Purchase Reserve Fund and the 2021 Transportation Vehicle Replacement Reserve Fund to the extent they are funded.

Why: The District receives NYS Transportation aid on 84.7% of the total purchase price of these vehicles. Using the bus purchase reserve to help offset the local cost (down payment) for this purchase makes this tax neutral. Replacing buses on a five-year cycle will ensure the District is reducing maintenance costs for the fleet by always having a bumper-to-bumper warranty in place on buses while also recouping NYS transportation aid.
