Parents receive quarterly grade cards and progress reports mid-way through each quarter. Parents in grades 2-6 can have access to their children's grades daily through the use of PowerSchool. Parents can communicate with their child's teacher as often as needed and information is provided monthly in classroom newsletters about the curriculum, what students are learning in the classroom and how parents can support learning at home. Information is available online about the curriculum and state standards.

Materials are provided throughout the year to help parents support their children's learning. This is accomplished through newsletters, Family Night events, and Parent/Teacher Conferences. Strengths:

-Student Achievement and growth continues to increase as demonstrated by APR, iReady, and Lexia reports.  
-Class sizes (average) meet DESE requirements for all grade level classrooms K-6. Math Diagnostic 3 data reflects 44% of students are performing on grade level or above. This is a 5% increase from the 21-22 school year.  
Reading Diagnostic 3 data reflects 60% of students are performing on grade level or above. This is a 7% increase from the 21-22 school year.

Weaknesses:

-Student Mobility: CP families are very transient.  
-Discipline: At-risk students continue to require alternative interventions including physical, mental and behavioral health services.  
-Demographics: Carden Park has 100% F & R lunch. Approximately 60 ESOL students and 10% were homeless students.  
Discipline referral rates are: 1335 total for 22/23 school year.

Summarize the analysis of data regarding **student achievement**:

Strengths:

Math Diagnostic 3 data reflects 44% of students are performing on grade level or above. This is a 5% increase from the 21-22 school year.  
Reading Diagnostic 3 data reflects 60% of students are performing on grade level. This is a 7% increase from the 21-22 school year.

Weaknesses:

-Our students struggle to enter school reading and comprehending on grade-level which impacts student's ability to be successful in ELA and Math.  
-Our APR report reflects a loss of points in student attendance.  
-Although Carden Park students have made 122% annual typical growth in reading during the 2022-23 school year, 39% are performing below grade level in reading  
  
-Although Carden Park students have made 94% annual typical growth in math during the 2022-2023 school year, 56% are performing below grade level in mathematics

Indicate needs related to strengths and weaknesses:

- While we have shown growth in all areas, including reading, there is still more growth to be made. We will continue to support students through personalized support/plans and small group instruction in reading and math. There is a need for intervention in providing a safe learning environment due to demographics of our student population.

Strengths:

District approved curriculum and resources that area aligned to the MO Learning Standards; offer 1 to 1 technology to all students in grades K-6 that can be utilized for a variety of web-based programs that meet students at their individual levels; teachers participate in JEPD every other week along with quality professional development opportunities provided by the school district. Carden Park provides a variety of intervention supports through MTSS, RTI, Special Education, ESOL programming, Reading, Behavior and a Math Interventionist.

Weaknesses:

-Continue to need more reading, math and behavioral intervention services.

Indicate needs related to strengths and weaknesses:

Support needed for teachers in how to utilize technology to support instruction. There is a need to continually develop new teachers.

Weaknesses:

-As of May, we are in need of 3 classroom teachers.

Professional development has been provided in the areas of Kagan, teach like a pirate, PBIS, District Engage Summit, Trauma Training, Math/ELA, and data teams. This will continue during the next school year with the addition of Clarity and 3d coaching.

Provide many opportunities for all families to be engaged with the school throughout the year. Events focus on education, how we teach these areas and how parents can help at home. We hold Math, Literacy and Maker Fair family involvement activities. There are also opportunities provided for parents to come in to the classrooms during the school day to be a part of lessons, to volunteer, and participate in meetings involving their child/children. We have a website that is kept current, a Twitter account to highlight events, and a monthly school newsletter to all families and staff. We have two full-time school nurses who not only provide for student's healthcare needs, but provide lessons on hygiene, brushing your teeth, a healthy lifestyle, and changes your body goes through as you get older.

Weaknesses:

We have a small population of families that are engaged and participate in the variety of events offered.

Continue to work to engage additional families and find ways to support and communicate with CP families.

Strengths:

Our school has a Leadership Team that meets monthly to make decisions about organizational and instructional aspects of our school. There is a system in place to promote shared leadership and opportunities for all staff to be involved. All staff work to ensure that "Educate each child for success" (the SJSJ mission) as we educate the whole child. As demonstrated by the Gallup Poll student survey, our students outperform national peers in the areas of hope and engagement. Our school values supporting the Whole Child as proven by our partnerships.

Weaknesses:

As demonstrated by the Bright Bytes survey, our students need more exposure to collaborating online across time and space with peers.

Indicate needs related to strengths and weaknesses:

Our school continues to learn about and will spend time focusing on having a growth mindset and how to instill that idea within our students. We recently adopted the growth mindset character traits of Angela Duckworth.
