Parents receive quarterly grade cards and progress reports mid-way through each quarter. Parents in grades 2-6 can have access to their children's grades daily through the use of PowerSchool. Parents can communicate with their child's teacher as often as needed and information is provided weekly in classroom newsletters about the curriculum, what students are learning in the classroom and how parents can support learning at home. Assistance is provided through Title Services and the MTSS process. Information is available online about the curriculum and state standards.

Teachers and staff receive professional development opportunities in JEPD and staff meetings through out the school year that include communication and working with parents.

Professional development has been provided in the areas of data analysis and math Iready. The focus for 23-24 will be using data to make instructional decisions in the classroom and the implementation of new ELA curriculum and the continuation of PBIS Tier 2 training.

Results of our survey indicated that parents do not know how to be more involved in the school.

There is system in place to promote shared leadership and opportunities for all staff to be involved. The school has a MTSS team that provides support to teachers to help struggling students, attendance team is being established for the 22-23 school year to support students who struggle to come to school, climate committee and Parent Involvement Committee to engage parents.

Office referrals increased for the 22-23 school year.
