The SELPA Chief Executive Officer, Chief Business Officer of Orange USD shall be responsible to monitor on an annual basis the appropriate use, allocation and distribution of all funds allocated for special education programs. Final determination and action regarding the appropriate use of special education funds shall be made through the Annual Budget Plan process. All Federal and State Funds allocated for special education programs shall be used for services to students with disabilities as outlined by California Education Code and IDEA.
