During the April 17, 2023, Business Meeting

Chester County Intermediate Unit Core and Occupational Budget resolutions for 2023-2024. The estimated cost to the Great Valley School District for the Core Budget is \$47,615, and the Occupational Budget is \$987,852. The motion passed by a unanimous roll call vote of 7 to 0.

Mr. **Peterson** reviewed the Preliminary Budget and Final Budget Notice, the 2023-2024 PDE 2028, and the Budget Presentation. During the Budget Presentation, **Mr**. **Peterson** shared the total expenditures, capital plan summary, preliminary budget, and the upcoming items to monitor.

Mrs. **Armstrong** made a motion, with a second by **Dr**. **Mehta**, to approve the preliminary budget resolution setting the preliminary budget with a real estate tax increase of 3% for the 2023-2024 fiscal year, where the Act 1 index allows up to a 4.1% increase. The millage rate would increase from 22.92 mills to 23.61 mills. The motion passed by a unanimous roll call vote of 7 to 0.
