NON-PARENT CUSTODIAN AFFIDAVIT

The following acts and powers are granted by this Affidavit:

1. To receive and discuss the student's class work with appropriate District personnel.
2. To examine and receive copies of the student's Lake Worth School District records and report cards and other documentation maintained by the school district.
3. To give permission for the student's participation in various activities such as, but not limited to, athletics, extracurricular activities, field trips and team and student travel.
4. To be notified concerning medical problems or issues and to give consent for the care and treatment of the student.
5. To be notified and consulted concerning the student's attendance and tardiness.
6. To give permission for any disciplinary actions involving the student by District personnel.
7. To perform any other duties and responsibilities normally afforded to the parent(s) of students in the Lake Worth Independent School District; including but not limited to the duty of ensuring the student is sufficiently in attendance at school and to avoid truancy charges.
8. To give parental permission for academic or psychological testing that may be performed by District personnel, including but not limited to special education, 504, and dyslexia, in place of the parent and attend and fully participate in all meetings, including but not limited to ARD meeting and 504 meetings as the student's representative.

PLEASE CAREFULLY READ THE FOLLOWING BEFORE SIGNING

FAMILY CODE: 41.001. Liability

A parent or other person who has the duty of control and reasonable discipline of a child is liable for any property damage proximately caused by: (1) the negligent conduct of the child if the conduct is reasonably attributable to the negligent failure of the parent or other person to exercise that duty; or (2) the willful and malicious conduct of a child who is at least 10 years of age but under 18 years of age.

FAMILY CODE: 41.002. Limit of Damages

Recovery for damage caused by willful and malicious conduct is limited to actual damages, not to exceed \$ 25,000 per occurrence, plus court costs and reasonable attorney's fees.

EDUCATION CODE: 25.001(h)

In addition to the penalty provided by Section 37.10, Penal Code, a person who knowingly falsifies information on a form required for the enrollment of a student in a school district is liable to the district if the student is not eligible for the enrollment in the district but is enrolled on the basis of the false information. The person is liable, for the period during which the ineligible student is enrolled, for the greater of: (1) the maximum tuition fee the district may charge under (Education Code) Section 25.038; or (2) the amount the district has budgeted for each student as maintenance and operating expenses. In addition, presenting false information or false records is a criminal offense under Penal Code 37.10.
