SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. The initial plan was designed based on the input of multiple stakeholders and district goals, as outlined by the Board of Education. Once drafted, the plan was distributed to the district listserv and the all district stakeholders via Blackboard Connect for an open comment period. A public hearing was held on June 21, 2021 in conjunction with a scheduled BOE meeting at which stakeholders attended and asked questions. Once approved by the BOE, the plan was again distributed to stakeholders and the school community. The district has planned, at minimum, quarterly meetings to discuss spending and any need to amend the grants in any way. The stakeholder group remains intact and, moving forward, will include a student representative.

- 3. In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.**

The District intends to maintain necessary protocols for cleaning and sanitizing in the post-COVID period by keeping an additional first shift cleaner in place. The person has and will continue to clean doorknobs and handrails, provide additional sanitation after breakfast and lunch periods, and address supply needs around the school throughout the day while students are in session. Further, the District will be leasing a new self-propelled floor cleaner to support daily cleaning procedures without requiring a staff member to walk away from other duties. Other maintenance items needed to maintain air quality, provide PPE, and general cleanliness will be included in our spending plan.

Since the onset of the pandemic and the high-traffic needs of the Health Office, the District has employed an aide to support the nurses in making phone calls, keeping detailed records, and reporting data to the local DOH. That position will also be maintained for at least another school year to promote efficiency for that department.

Upon reopening in the 2020-2021 school year, COVID protocols and restrictions required significant changes to the daily instructional schedule and work day for our faculty and staff. The District has developed, and will continue to offer, after school childcare for district employees. This program provides a safe and engaging environment for Letchworth students run by district support staff who earn a stipend for their time.

- 4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.**

The District intends to monitor student needs using a variety of evidence-based protocols and systems already in place. Our Child Study Team (elementary), and MTSS teams in the middle and high schools will evaluate student performance data as well as behavioral needs on, at minimum, a monthly basis. Grade-level teams meet weekly and will provide additional supports through academic intervention services and/or afterschool tutoring.

Students in grades K-8 are assessed using the AIMSweb Plus benchmarking and progress monitoring tool three or four times per year to determine any specific skill deficits in reading and mathematics that require additional supports. At the high school, local assessment and classroom observation data is discussed by grade-level teams, service providers, and counselors to identify students who require AIS in their daily schedule. Schedules are adjusted every 5 weeks based on student progress and continuing needs.

Middle and High School students in need of additional academic supports, as identified by AIMSweb or local assessments, will be provided afterschool tutoring at least twice a week with certified teachers. This time will be used to build skills identified as deficits for individual students using intervention tools for practice (IXL, Kahn Academy) or more targeted with resources from Really Great Reading (Boost, Blast, Blitz for example). Additional needs of students will be met in the form of credit recovery options. Students in the elementary school who are not already being serviced by reading or math interventionists during the school day will be discussed through Child Study meetings to determine the best path to academically support them, whether through AIS or additional testing.

Letchworth prides itself on the phenomenal Agriculture and Technology curricular programs we have offered students for several years. Additional funding will support our goals to further enhance the program, building on the Ag/Tech Academy and offering the potential for CTE-accredited coursework here on campus. Money will be set aside for *instructional training opportunities with Project Lead the Way, the CASE Institute, iCEV curriculum development, and other professional development opportunities* for all of our teachers to continue making updates to our offerings for several years. Further, we will prepare to hire for our STEAM initiatives as the capital project takes shape, the rooms are furnished with needed supplies and materials, and the curriculum is fully developed.

Summer remedial and enrichment programming will take shape in the summer of 2021. The first of what we hope will be many summer theatre camps will be planned to produce The Lion King Jr. for students in the elementary and middle school to perform for the community next fall. Additional programming will bloom from student and parent input and involvement over the next four summers. The District hopes to also find opportunities to offer after school supports and enrichment programs suited to all students and interests.

Over the life of the grant, the District will utilize its shared decision-making committee to annually review the needs and priorities of our students, staff and infrastructure in order to amend spending projections and purchasing plans. The stakeholders involved will analyze students' academic and behavioral data, reports from principals and school counselors, the CSE and new initiatives directed by the NYS Department of Education to make appropriate revisions to this plan. Other categories of potential spending (maximizing in-person instruction time and support for early childhood education) will also be considered in annual reviews. All funding proposals will exist for the life of the grant, as specified, or be paid for in the local budget upon the grant's expiration.

6. In the space provided below, please describe how the LEA will spend its remaining ARP ESSER funds consistent with section 2001(e)(2) - the allowable uses of funds - of the ARP Act.

Our district will be utilizing federal funds for the next four years to manage our educational technology needs and replacement costs. *New Chromebooks, chargers and safety cases* will be purchased within the same rolling timeline previously used for grade levels. Further, our first generation *COWs* (or “computers on wheels”) are reaching the end of their operational lives and will be replaced with updated versions that can process new software and services.

In December 2020, our school community approved a \$20 million capital project that includes several additions to our Agriculture and Technology instructional areas. These spaces, called STEAM rooms, will be supplied with *high-end computers and printers as well as other educational technology* to support modern curriculum options and programming once our renovations are completed.

In the space provided below, please describe how the LEA will ensure that the interventions it implements, including but not limited to the interventions implemented under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time, will respond to the academic, social, emotional, and mental health needs of all students, and particularly those students disproportionately impacted by the COVID-19 pandemic, including students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students.

The pandemic has impacted our students, faculty and staff in a myriad of ways since its onset in March 2020. The disruption of our educational program that year put many students at an early disadvantage in the new year both academically and socially/emotionally. Letchworth has been a PBIS (Positive Behavior Intervention Supports) school for more than a decade, and our dedication to providing those supports has only strengthened since the school closure. At all building levels - elementary, middle and high - the District is dedicated to providing *new training to teachers and students* to further bolster our students’ success in school. Materials and professional signage will be included in those expenses to create an environment fully immersed in the values of empathy, restorative justice, and academic excellence.

Instructional best practices for providing academic intervention to students requires a tiered approach. A multi-tiered system of support (*MTSS team*) will be established to examine interventions and materials, collect and analyze data, and bridge student learning gaps created during the school closure period and disruptions to the 2020-2021 school year. A *coordinator* will work with service providers, teachers, staff and parents to develop instructional goals and implement strategies to support every student.

Ongoing professional development for all members of our instructional and non-instructional staff and administration will be prioritized annually. In keeping with best practice for adult learners, models of learning will be implemented on a number of topics that will include using instructional technology, providing mental health and social-emotional supports in the classroom, adapting instruction to a block schedule, and other content-specific needs of our faculty and staff. One of our district-wide philosophies has always been that, before a student can learn they must feel safe. Students need a connection to school, to people in the school community who can provide that sense of belonging that will spur academic success. Letchworth will utilize funds to maintain *full-time school counselors in the elementary and middle schools* for the next three years before moving those positions back to the local budget. These counselors will continue providing Second Step lessons and contributing to students’ daily lives at school by introducing them to college and career readiness activities. Additionally, the District will look to hire another *school social worker to support our littlest learners* in our 3- and 4-year old programs. School readiness for early childhood is always a concern, and this professional would be an asset to both our students and the faculty who work in our preschool and prekindergarten classrooms.

The District's initial plans for the spending of ARP funds was posted on the district website and sent to families/community via Blackboard Connect. A public hearing was held prior to the Board of Education meeting on July 6. Visitors asked questions and clarified priorities of the BOE and district administration at that meeting. Moving forward, a district-wide committee of administration, BOE members, teacher and support staff unit members, and parents has been created. The Federal Grant Review Committee will meet three times a year to conduct a review of spending, priorities, and needs for amendment throughout the grant funding period.
