

Measure S History

In accordance with 1213-01 Resolution, approved by the Temple City Unified School District Board of Education on July 18, 2012, the Board committed to maintaining awardwinning education in safe schools and upgraded classrooms, libraries, science labs and technology systems to keep pace with 21st century learning standards and keep local test scores high. To that end, the Board evaluated the District's urgent and critical facility needs and determined that each of the neighborhood schools within the Temple City Unified School District needed to be upgraded, repaired, and improved in order to enable the District to maintain and enhance the education of all of the students in the District.


As a result, on November 6, 2012, the voters of the Temple City Unified School District authorized Measure S under the Proposition 39 statutes. Measure S authorized the issuance of \$128.8 million in General Obligation Bonds (the "Bonds"). The net proceeds of the Bonds are intended to be used to maintain high quality education, prepare local students for college and careers, equip schools with current technology, upgrade security, fire safety, electrical, plumbing, heating/cooling systems, repair old roofs, upgrade science labs, construct, repair, acquire classrooms, vocational education facilities, sites, facilities and equipment. Measure S was approved by 64.35% of the voters within the boundaries of the District.

State School Facility Funding Program (SFP) Breakdown of District SFP Funds

The Temple City Unified School District has been part of the State School Facility (SFP) grant funding program for over 20 years. Over the past 3 years, the District has been able to successfully obtain over **\$33.3 million** in State SFP grant funding for its priority modernization and new construction projects.

The District continues to pursue new opportunities for any potential future State SFP grants for its priority school projects. The receipt of future State grants is predicated on: 1) the District meeting the State's eligibility requirements; 2) the voter approving a new State School Bond Measure; and 3) State funding amounts remaining at the current 50/50 for eligible new construction and 60/40 for eligible modernization projects.

Modernization & Improvement Projects Completed Projects – Oak Intermediate School

The District has successfully completed the following scope of work with Measure S G.O. Bonds and its local funding sources at Oak Intermediate School, since 2013.

- Resurfaced asphalt courts with colored coating to help with extending the life of the asphalt, lowering the surface temperature at the playground
- ✓ Provided abatement of existing flooring in the 400 and 500 wings, replacing with new carpet
- Removed existing grass at the back playfield, installed new irrigation system and planted new grass
- ✓ Installed new drinking fountains at back field
- ✓ Re-keyed and added new hardware to the 100 wing
- ✓ Installed crash padding on the gym walls
- ✓ New exterior paint

The District has successfully completed the following scope of work with Measure S G.O. Bonds at Temple City High School, since 2013.

- ✓ Constructed 3 new masonry buildings connected by exterior walkways
- ✓ 32 new classrooms, 2 new elevators, 4 new student restroom and four new staff restrooms
- ✓ Technology package: interactive display, speaker system, multiple displays
- ✓ Flexible furniture and teaching spaces
- ✓ Exterior learning courts placed at each building
- ✓ Construction of a new competition size pool and modernization of locker/team rooms
- ✓ New masonry pool equipment building
- ✓ New masonry main electrical room and trash enclosure
- ✓ New concession room
- ✓ Expanded locker room layout with new restroom and shower facilities
- ✓ New multi-use ball field
- ✓ New softball field and scoreboard
- ✓ Rekeyed and replaced hardware on the 400/500 wing and the portables
- ✓ New bleachers for baseball and new additional bleachers for softball
- ✓ Regraded and resurfaced the track adding twenty yards of fresh track mix
- ✓ New 4' foul line fences at the baseball field
- ✓ New carpet in 3 classrooms in the 500 wing
- ✓ New retaining wall, mow curb, TCHS logo at back field
- ✓ New fencing at tennis courts and along Camino Real
- Partnered with the city and installed new irrigation for new trees planted by the city on Camino Real
- ✓ Additional new technology and furniture for Phase 1A








Measure S New Project – Temple City High School Stadium Renovation

The Project is expected to include, without limitation: (a) replacement of existing stadium, including: (1) synthetic track and field; (2) bleachers; (3) press box; (4) Sports lighting; (5) scoreboard; (6) ticket buildings; (7) field house with team rooms; (8) concessions and toilets; and (9) fencing and gates; (b) replacement of existing baseball complex, including: (1) field; (2) bleachers; and (3) fencing and gates; and (c) construction of four (4) new tennis courts, including: (1) sports lighting; (2) fencing and gates, with post-tension concrete slab; and (d) Miscellaneous sitework and site structures.




Measure S New Project – Temple City High School Stadium Renovation
