Student Transportation Agreement  
Release of Liability and Waiver of Claims

The County School Board of York County, Virginia (School Division) provides students and families with the option of traveling to and from athletic activities/events by private automobile (The Peninsula and Williamsburg areas only).

I am the parent or legal guardian of the student named below (Child) and I authorize my Child, for the Child's own benefit, to travel by private automobile to and from athletic activities/events sponsored by the School Division.

In consideration of my Child being authorized to travel to and from athletic activities/events in a private automobile, either driven by my Child them self or by an adult authorized by me as parent or legal guardian, I hereby, for myself and on behalf of my Child, our heirs, executors, administrators, successors and assigns, agree to the terms and conditions set forth below.

I understand that use of a private automobile is not required for my Child to participate in athletic activities/events sponsored by the School Division.

I acknowledge that I have elected to allow my Child to travel by private automobile voluntarily in lieu of transporting my Child myself.

I acknowledge that my child will not be supervised by School Division personnel during transportation by private automobile.

I understand and agree that neither the County School Board of York County, Virginia nor the York County School Division will be responsible or liable for any and all damages to persons or property caused by, resulting from, or arising out of any act or omission on the part of my Child, the adult authorized to drive my Child or any other person in the automobile during the period in which my Child is traveling to and from athletic activities/events in a private automobile.

The options available for private automobile transportation to athletic activities/events sponsored by the School Division include:

1. Transport by the student them self by private automobile; or,
2. Transport by another adult specifically authorized to transport the student on the attached Athletic Travel Permission Form.

I recognize that transportation by private automobile may expose my Child to the risk of significant injury and/or death. As such, I understand that any injuries or damages that may result could arise from the actions, inactions or negligence of my Child or others, including the County School Board of York County Virginia, its officers, agents, volunteers and employees and the York County School Division.

I understand that by signing this Release of Liability and Waiver of Claims, on behalf of myself and my Child, I am voluntarily assuming all risks of property damage and bodily and personal injury and death, inherent or otherwise, associated with my Child's travel by private automobile.

I hereby waive, release, and forever discharge the County School Board of York County, Virginia, its officers, agents, volunteers and employees, and the York County School Division, from any and all claims, liabilities, demands, rights, damages, costs, loss of service, expenses and compensation whatsoever, as well as any actions, and causes of action of every kind, whether known or unknown, foreseen or unforeseen, which have now or may hereafter accrue, arising out of or relating in any way to my Child's travel by private automobile to and from athletic activities/events sponsored by the School Division.

I agree to indemnify and hold harmless the County School Board of York County, Virginia, its officers, agents, volunteers and employees, and the York County School Division, from any and all claims, liabilities, and losses of any type, including all costs, attorney's fees and appeals and other expenses, resulting from any claims arising out of or in connection with my Child's travel by private automobile to and from athletic activities/events sponsored by the School Division.

The undersigned further declares and represents that this Release of Liability and Waiver of Claims contains the entire agreement between the parties hereto, and that the terms hereof may not be modified except in writing signed by the undersigned and an authorized representative of the School Division.

This Release of Liability is binding on all my and my Child's heirs, executors, next of kin and assigns, and all persons who may claim by or through me or my Child.

CAUTION: READ THE FOREGOING RELEASE OF LIABILITY AND WAIVER OF CLAIMS BEFORE SIGNING. THIS DOCUMENT IS VALID UNLESS AND UNTIL REVOKED IN WRITING AND REVOCATION IS DELIVERED TO THE COUNTY SCHOOL BOARD OF YORK COUNTY, VIRGINIA.

By signing below and completing the attached Athletic Travel Permission Form, I hereby grant permission for my Child to travel to and from athletic activities/events by private automobile. I have read this Release of Liability and Waiver of Claims, and voluntarily sign below, and agree to the releases, waivers, and indemnifications contained herein, and agree to be bound by the terms and conditions stated above.
