iPad Insurance Form
(FORM MUST BE COMPLETED BEFORE STUDENT CAN GET THEIR IPAD)

Parents and students are responsible to pay the cost of repairs for any damage to their school-issued computing device. This protection plan will help guard against the expense of repair costs for accidental damage up to and including the cost of a full replacement for a device that is damaged beyond economical repair.

Participation in the Damage Protection Program is voluntary but is a requirement to be filled out for a student to receive a computing device for school use. Please review the information provided below and select whether you wish to purchase the insurance. *This form must be submitted in order for the student to receive their device even if you choose not to enroll in the Damage Protection Program.*

Protection Program Cost and Coverage Details

The participation fee for the Damage Protection Plan is \$40.00 (*nonrefundable*) for the following coverage:

- • Protection plan will cover up to one (1) repair at \$15 co-pay.
- • Devices damaged beyond economic repair: \$50 replacement fee; limited to one time per coverage year.
- • In the event that the student's school-issued computing device is lost or stolen, parents and students are responsible to pay the \$50 replacement fee; limited to one time per coverage year.
- • Students will be provided a free loaner device during the repair period.

All subsequent repairs will be billed per the **Repair and Replacement Costs Without Protection Program Coverage** pricing listed below.

Protection Program Exclusions

- • Lost power supplies
- • Lost or damaged accessories

Repair and Replacement Costs Without Protection Program Coverage

Parents and students who do not elect coverage are responsible to immediately notify and arrange for repairs through the school. Replacement parts and repair costs will be billed as follows:

Approximate Costs

- • Broken iPad Case: \$ 110.00
- • Power Cord: \$ 19.00
- • Power Brick \$19.00
- • Full Device Replacement \$330.00

Do you wish to participate in the Damage Protection Plan?
