Dear Parents and Guardians,

We encourage students to ride the bus to and from school whenever possible; however, if your child does not ride the bus in the morning, please note the following procedures for student drop-off in the front parking lot:

- 1. Pull through the parking lot, in a single file line, when dropping off your child. That way we may be able to have several vehicles dropping off students at one time.
- 2. Since staff members will assist your child in exiting your vehicle, do not get out of your vehicle unless absolutely necessary.
- 3. Once your child has left your vehicle, proceed out of the parking lot so that other parents may drop off their children.
- 4. Do not park your vehicle in the drop-off zone and walk into the school building.
- 5. Do not drive around the line of vehicles waiting to drop off students.
- 6. Any student arriving after 9:20 a.m. must be signed in by a parent or guardian at the main office before entering the classroom.

Car riders may not be dropped off prior to 9:00 a.m.

If your child does not ride the bus daily in the afternoon, please note the following procedures for student pick-up in the front parking lot:

- 1. Pull through the <u>BUS</u> parking lot, in a single file line, when picking up your child. That way we may have several vehicles picking up students at one time.
- 2. Since staff members will assist your child in entering your vehicle, do not get out of your vehicle unless absolutely necessary.
- 3. If your child has not arrived when your vehicle enters the pick-up zone, proceed through the bus lot and loop back to get in line again.
- 4. Do not park your vehicle in the pick-up zone and walk into the school building.
- 5. Do not drive around the line of vehicles waiting to pick up students.
- 6. Car riders will be dismissed by 4:00 p.m. after all bus riders have been dismissed.

<u>Parking on Matula Drive is prohibited between the signed areas prior to 4:00 p.m. Monday-Friday. Please follow the directions of the Matula building service staff member, who will be posted at the La Plata High School service entrance.</u>

We will continue with numbered hang tags for the parents/guardians of car riders. Each family will be issued two numbered hang tags, and students will have bookbag tags with corresponding numbers. This system been very successful in expediting the daily pick-up process. Previous year's car hang tags should be discarded as they have expired.

If your child is not a car rider on a daily basis, he does not need a car rider tag. On the days he is being picked up as a car rider, please send a note to his teacher. You will then park your vehicle, come into the building and sign him out in the main office. Early departures must occur prior to 3:30 PM.

All dismissal changes must be made ahead of time in writing. Emergencies will be handled on a case-by-case basis.

Thank you, in advance, for adhering to the above procedures, as the safety of our students and staff members is our priority.
