WHEREAS the District has determined that pursuant to Section 617.5(c)(2) and (10) of the SEQRA regulations, the Project collectively constitutes a Type II action exempt from SEQRA review since the Project involves the:

- (2) replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site, including upgrading buildings to meet building or fire codes; and/or
- (10) routine activities of educational institutions, including expansion of existing facilities by less than 10,000 square feet of gross floor area and school closings, but not changes in use related to such closings.

NOW, THEREFORE, the Board of Education of the Seneca Falls Central School District hereby resolves as follows:

- 1. The above whereas clauses shall be deemed to have the same force and effect of each of the other clauses set forth herein.
- 2. The Project constitutes a Type II action pursuant to Section 617.5(c)(2) and (10) of the SEQRA regulations in that such work constitutes "replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site...(including certain upgrades) and/or "routine activities of educational institutions" and, as such, no further review or action is need be undertaken by the District pursuant to SEQRA.
- 3. This resolution shall take effect immediately.

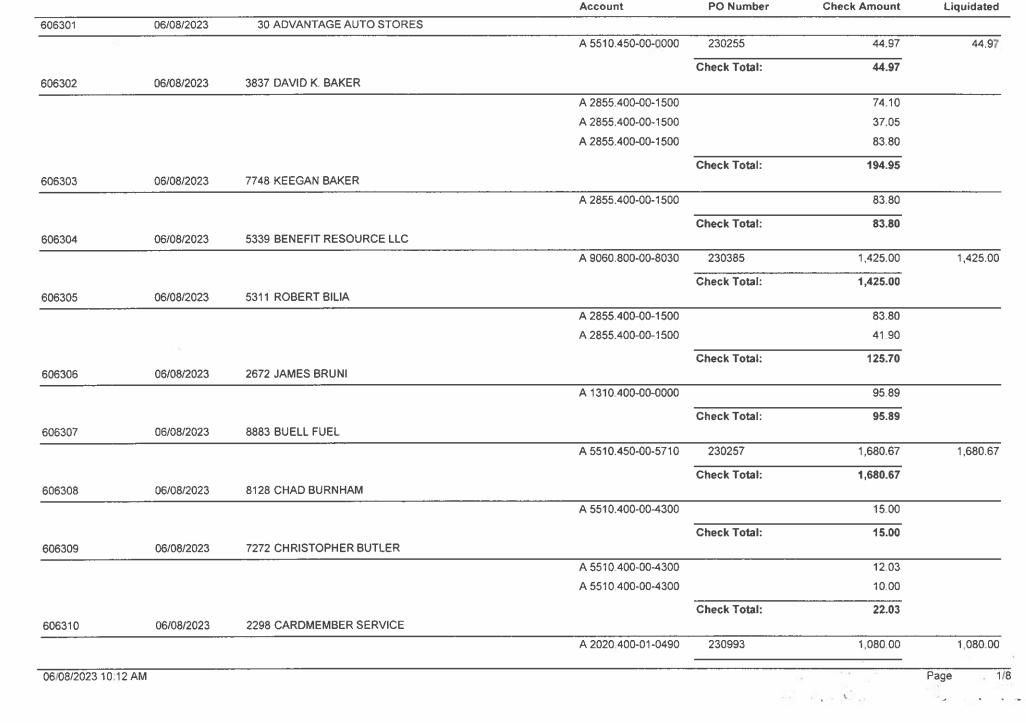

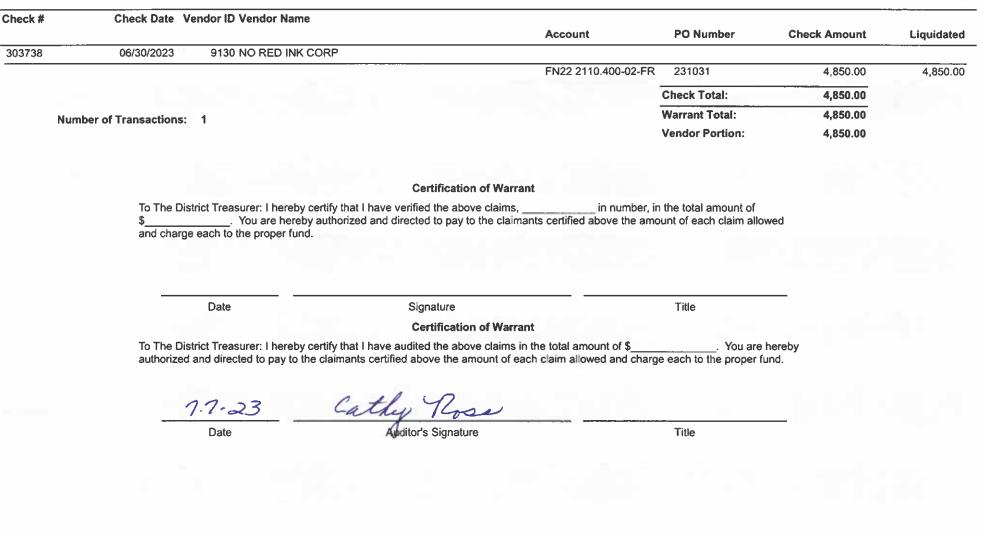

# **Memorandum of Agreement**

This agreement is made between the Superintendent of the Seneca Falls Central School District (hereinafter the "District") and the Seneca Falls Education Association (hereinafter the "Association").

**Whereas** the District and the Association recognize in Article X, Section F, that Business, Family & Consumer Science, and Health are listed separate under the "Minor Special Area Subject Department Chairperson, and

**Whereas**, the District and the Association recognize that in the Department Chairperson Table, the Family and Consumer Science and Health are combined as a minor decimal.

# Now, therefore, the parties agree that ...

- Article X, Section F "Department and Chairperson and Team Leaders", 2b: "Minor Special Area Subject Department Chairperson" will state the following:

\*\*\*Family & Consumer Science, Health, and Business will be added to the major decimal Compensation section. The department chairperson will still be considered a minor special area. The compensation will be computed using the following decimal:

This agreement is in effect for the 2023-2024 school year, and continues through June 30, 2026 (Contractual ending).

# In addition, the parties agree that...

In accordance with Article X, Section F "Department and Chairperson and Team Leaders", 2b specifically related to Family & Consumer Science, Health, and Business, that while Mrs. Dana Colvin is appointed to this department chair position, she will be compensated the same amount she was compensated as a department chair during the 2018-19 school year. She will be paid this same amount for each year she is appointed to the department chair for Family & Consumer Science, Health, and Business. The amount will not increase during her time in this role and if there is a break in her service for this position specifically, she will be paid per the contract language established above using the decimal system.

This agreement shall constitute the full and complete resolution of this issue. Any dispute arising from this issue or agreement that cannot be resolved informally, shall be resolved through the contractual grievance process. This agreement will not alter any other benefits and/or rights provided in the collective bargaining agreement for either party. Likewise, this agreement does not establish a precedent.
