MESSAGE FROM THE PRINCIPAL...

Dear Early College Families,

As we wrap up 1st semester and prepare for Winter Break, I want to take the time to reflect upon things that are positive in our school.

First, District 11 voters and parents chose to pass 3E at our November election. This is a HUGE win for all of our students and our staff, as it means that resources (such as our Counselor Corps Grant funded counselor position) will remain intact.

Next, Dr. Gledich and Human Resources approved our two science teacher FTE requests, which means that we are now in a position to solidify Horticulture as a Career Pathway moving forward into the 2018-2019 school year—while providing full time science access to all of our students at Early College.

Additionally, the Naming Committee convened on Wednesday, 11/15, and unanimously supported the request to submit the name Odyssey Early College and Career Options to the Board of Education for consideration in our request for a personal identity and brand. Now we wait for the BOE's "non-action" and "action items" meetings for their decision...

During our audit visit on 11/9, the Higher Learning Commission was pleased and impressed with our partnership with Pikes Peak Community College. They supported our work with students and we received extremely positive feedback regarding who we are and what we do.

Career Pathways continues to offer interesting Career Panels that are highly relevant to our students. The latest Career Panel offered in November involving the Colorado Springs hospitality community was well organized, beautifully executed, and very interesting. How fortunate I feel to get to work with individuals who are making exciting connections happen in our business community. I look forward to the next Career Panel on February 8 that will feature professionals who will speak to their field of visual and design arts.

The Rotary Club of Colorado Springs (North location) reached out to Early College & Career Pathways. Their correspondence with us proved fruitful as we now have a new partnership in place for providing additional job shadow and internship experiences, as well as scholarship opportunities for our students.

EARLY COLLEGE NAME CHANGE UPDATE

Per Board Policy, FF, Naming of District Facilities, Properties and Assets, the District naming committee was convened on November 15, 2017 to consider bringing forward a recommendation to the Board of Education for the purpose of reassigning a school name to the Early College High School. The D11 naming committee, made up of staff, parents, and community members, reviewed the name submitted by Aurora Umana-Arko, principal, and Sean Norman, dean of students, Early College High School. The committee moved to bring the submission to the Board as a non-action item on December 13, 2017. The name of the submission to be considered is Odyssey Early College and Career Options (Odyssey ECCO).

The School District 11 Early College High School opened in August 2013 as the "Early College High School." As written in the justification for the naming submission, submitters feel this name is a designation, similar to "elementary," "middle," or "high school." Submitters feel a need to have a name that makes the school stand out from others, and prevent confusion with another school by a similar name in the city. As part of the process to determine a possible name submission, staff at the Early College High School solicited name ideas from students, parents/guardians, community members, and alumni. Everyone was invited to vote on the name ideas, and the one with the most votes, Odyssey Early College and Career Options (Odyssey ECCO), was submitted to the naming committee.

ATTENDANCE

Dear ECHS Families,

It is hard to believe that a whole semester is almost completed! In an effort to support your student's success at the end of the semester, I wanted to remind you that your student's attendance is of utmost importance. Many studies support that student attendance is one of the top key indicators of success. Simply put, if students are not present, they are not learning and grades are suffering. However, we understand that there are valid reasons for students to miss school. School Board Policy JH outlines those valid excused absences as:

- 1. Temporary illness.
- 2. A student who is absent for an extended period due to physical, mental, or emotional disability (includes residential treatment centers) can be excused by a school administrator if documentation is provided by a doctor.
- 3. A student to whom a current age and school certificate or work permit has been issued can be excused by a school administrator if documentation is provided.
- 4. A student who is pursuing a work-study program under the supervision of a public school can be excused by a school administrator if documentation is provided.
- 5. Absences related to school activities can be excused by school administration.
- 6. Absences due to severe weather conditions will be excused on a case-by-case basis by school administration.
- 7. A student who is in the custody of a court or law enforcement authorities will be excused by a school administrator or designee.
- 8. Absences related to military service and the Interstate Compact Educational Opportunity for Military Children.

We understand that not all situations are outlined above. In those cases, administrators are willing to work with families in unique situations that impact attendance. In the case that your student is chronically absent, you will be required to provide a doctor's note for documentation of illness. All missed school should be reported to the ECHS attendance secretary within 48 hours of the absence. Thank you again for supporting your student's success.

LAPTOPS ARE BEING ISSUED TO EVERY STUDENT AT BEGINNING OF 2ND SEMESTER


When students return to school from Winter Break, they will be issued laptops to be utilized in school and at home for the remainder of the school year (Spring 2018). User Agreements will be sent home before the end of 1st semester.

Students will be expected to have their laptop user-agreements signed and turned in to Ms. Ladefoged at the same time that laptops will be distributed. Students will be expected to participate in the District 11 Laptop Insurance program, offered at a *pro-rated* rate of \$25 (rather than \$50) for regular lunch students, and on a sliding scale for free and reduced lunch students.

Because laptops will be issued to students, students will be expected to carry their laptops to every class throughout the Spring 2018 semester. Students should plan on charging their laptops at home the night before, so as to diminish the amount of charge time in class that will result.







Teachers and Technology Program

Examples of abuse, misuse, or neglect include, but are not limited to:

- Not handling device with care (don't drop, throw, bump or treat in a manner that can cause damage or drop heavy objects on top of the device).
- Remove the hard drive.
- Exposing device and drives to magnets.
- Exposing device to extreme temperature changes (by possibly leaving device in your vehicle).
- Getting the device wet or exposing it to water (by possibly getting food and drinks on device).
- Exposing device to dust and dirt.
- Leaving items on keyboard when closing device.
- Allowing device and peripherals to be used with unsupervised children and pets.
- Not ensuring that device is secure from theft at all times.

Other procedures to be followed:

- Remove or install the battery only when necessary and when powered off.
- Don't turn off the device when the hard drive LED is lit or hard drive is spinning.
- Clean the exterior periodically (when device is turned off).
- Keep the device free from viruses and use provided anti-virus software.

- Don't mar or mark the device with ink or other substances.
- Do follow the device shut down or suspend procedure.
- I will not change the standard configuration of the device and will not install non-district owned software, games, etc.
- I will not loan this device to anyone including other students and/or family members.
- I agree to comply with Board of Education policies, regulation and procedures, including any user agreement when using this device.
- I will not conduct personal business activities.
- I will not access or store pornographic or obscene materials on this device.
- I will only use my assigned device in my educational pursuits in the District.
- I will report any malfunction to the LTE or LTT as soon as there is a problem.
- Should I no longer be a student in my school, I understand this device is the property of Colorado Springs School District 11, and I will return it to the LTE or LTT before my last day.
- This device is subject to inspection at any time, including without prior notice.

In the event of a loss:

- If this District device is lost, damaged or stolen while assigned to me, I will immediately notify
 my LTE, LTT and/or Resource Officer (if my school has one). I also agree to notify the
 appropriate police agency and provide District Security and Risk Management with the police
 report. I also agree to work with District staff to notify the police, District Security, and Risk
 Management.
- I understand that I am responsible for the full replacement cost if there is damage, loss, or theft and will reimburse the District for the loss within 30 business days.
- I may choose to file a claim under my personal homeowner or auto insurance coverage to reimburse the District or I will reimburse the District directly for the loss within 30 business days.
- I understand the replacement costs for this District device will be determined by the District Technology Services staff. (Employee initials) _____ (Date) ____
- I understand that failure to comply with this procedure may result in disciplinary action.

Online Video Conferencing Usage (for example Skype)

Electronic devices will often include a camera that will permit the student and teacher to see video of each other in order to allow the student to better communicate with the student's teacher through Skype.

From time to time, the District has and will adopt policies, regulations, rules, guidelines and other guidance regarding a student's use of electronic devices. The student and parent/guardian, by signing this Agreement, affirm that the student and parent/guardian have had an opportunity to study the District's current technology use materials (the EHC series of policies, regulations and exhibits as well as the Student Code of Conduct) and have had an opportunity to ask any questions related to such materials. The student and parent/guardian acknowledge that the student has received training regarding use of electronic devices and access to the Internet. The student and parent/guardian also acknowledge that, because the District does not currently have the technological ability to limit use of such equipment for educational purposes, there are certain risks of misuse of the equipment, and this Agreement imposes additional responsibilities on the student and parent/guardian to protect against such misuse.

By signing below, the student agrees to comply with all requirements of the District's technology use materials (the EHC series), including without limitation requirements that:

- (a) The student must use the device only for District educational purposes.
- (b) The student must take reasonable steps to protect the device from damage.
- (c) The student will not allow others to use this device and will take precautions to assure that others do not use this device.
- (d) The student will not access any Internet materials using this device, other than materials necessary for educational purposes that comply with the District's technology use materials.
- (e) The student must promptly report any misuse of this device to the District.

The student hereby releases the District from any liability or other responsibility with regard to his or her use or misuse of this device. Unless otherwise expressly provided by the District in writing, not less often than each calendar quarter, the student must bring this device to a location directed by the District for inspection regarding compliance with this Agreement.

Parent/Guardian Commitments:

The undersigned Person is a parent or guardian of the student referenced herein. By signing this Agreement, the parent/guardian hereby expressly acknowledges that, although the District makes efforts to block inappropriate use of District technology equipment, there is no certainty that such efforts will always be effective. Accordingly, as a condition to permitting the student to utilize this electronic device, the parent/guardian agrees to meet certain requirements with respect to such usage as outlined below.

- 1. I, the undersigned parent/guardian, will explain to the student the requirements of the District technology use materials to the best of my ability, and will help the student to understand the responsibilities associated with possession and use of this device. These requirements include without limitation the specific requirements imposed on the student outlined above. Further, I will take responsibility to assure that the student complies with the obligation stated above to bring this device to the District periodically for inspection.
- 2. I acknowledge I will provide supervision to the student with respect to the student's use of this device, and I will take responsibility to assure that the student is using the device solely for valid educational purposes.

3. On my behalf and on behalf of the student, I hereby release the District from any liability or or responsibility with regard to any use or misuse of this device during periods when it is not being under the direct supervision of District personnel.
