





Book Selection

- To date, the district has received five formal book challenges.
- Two of the book challenges are still in the reconsideration process.
- Principals and librarians are aware that EF policies guide the reconsideration process and have been told that if they have concerns about a book, they are also able to challenge a resource (as allowed by policy).
- A team is working to revise Board Policy EF (LOCAL) and to draft an entirely new EF (REGULATION).

Developing and Revising Policies

- Continued cycles of review are in progress.
- A subcommittee of librarians began the process followed by feedback from senior staff, conversations with principals, and meetings with Board members who serve as policy liaisons.
- Once a final working draft is complete, EF (LOCAL) will be posted online for thirty days for public feedback. The Board must have three public readings before adopting a revised policy.

Human Sexuality Instruction



Human Sexuality Instruction

As required under HB 1525, passed by the 87th Legislature, Trustees will be asked to approve a resolution at their Dec. 13, 2021 Regular Meeting to convene the DSHAC to recommend curriculum materials for human sexuality instruction.

Background Information:

- Under this resolution, the DSHAC will review and recommend human sexuality instructional materials to be used by secondary students as well as resources for 5th grade human growth and development instruction.
- DSHAC recommendations will be presented for Board consideration in Spring 2022, following two public DSHAC meetings and an opportunity for stakeholders to review and provide feedback on instructional materials under consideration.
- As required under HB 1525, parents will be required to opt-in for their child to participate in human sexuality instruction in grades 6-8. To align our practices, SBISD also will adopt an opt-in approach for 5th grade human growth and development instruction.
- The district historically has followed an abstinence-based approach.
- During the week of December 6, letters will go out to parents of students in grades 6-8 to opt in for their children to participate in this instruction for Spring 2022.

Human Sexuality Curriculum

- Abstinence-based
- Taught in grades 6-8
- Once-a-week lessons, during Health Fitness classes starting in February
- Parents/guardians must consent by Opt-In
- Curriculum for Level 1 Instruction is linked to the parent form for viewing and is also included on the <u>Public</u> <u>DSHAC Website</u>



Parent Consent Form Regarding Middle School Human Sexuality Instruction



Dear Parent/Guardian:

In accordance with EHAA(LOCAL), the Spring Branch Independent School District provides human sexuality instruction in compliance with law and Board policy. As required by law, the District must obtain written consent before a student can be provided human sexuality instruction.

Your child is scheduled to receive Level I human sexuality instruction one day each week beginning February 2, 2022 and ending March 9, 2022.

If we do not receive your signed consent below by January 7, 2022, the student will not be permitted to participate in the human sexuality instruction and will be assigned an alternative instructional activity.

District School Health Advisory Council (DSHAC) What is a DSHAC?

• Required by law and governed by legal and local policy, a DSHAC is a group of individuals representing segments of the community who provide advice to the district on coordinated school health programming and its impact on student health and learning.

In SBISD, the DSHAC is comprised of a school board trustee, SBISD parents, community partners, and representatives from Child Nutrition Services, Systems of Care, Health Fitness, Safety and Security, SBISD Police Department, Community Engagement, Guidance and Counseling, and Student Support.
