<u>CS-119</u> – Due to reinstatement of a deleted student that requires a personal aide, a personal aide was assigned effective October 5, 2020. Based on the per diem of the first aide on this route, the contractor has requested \$55.00 per day for the 164 days remaining in the school year for a total increase of \$9,020. The amended total cost of this contract is now established at \$74,900 (\$55,815 - route + \$10,065 - aide + \$9,020 - aide). This route now transports students from Linden to and from Center for Lifelong Learning in Parlin.

<u>CS-362</u> – Due to addition of a student to the route that requires a personal aide, a personal aide was assigned effective October 19, 2020. Based on the per diem of the first aide on this route, the contractor has requested \$43.00 per day for the 155 days remaining in the school year for a total increase of \$6,665. The amended total cost of this contract is now established at \$66,938 (\$52,490 - route + \$7,783 - aide + \$6,665 - aide). This route now transports students from Westfield to and from Westfield High School in Westfield.

 $\underline{\text{CS-542}}$  – Due to the district's request, a personal aide was assigned effective October 26, 2020. Based on the per diem of the first aide on this route, the contractor has requested \$75.00 per day for the 148 days remaining in the school year for a total increase of \$11,100. The amended total cost of this contract is now established at \$91,560 (\$66,960 - route + \$13,500 - aide + \$11,100 - aide). This route now transports students from West Orange to and from the Phoenix Center in Nutley.

 $\underline{\text{CS-}112}$  – Due to the deletion of the only pupil transported on this route, it was cancelled effective October 23, 2020, after transportation services were provided for 35 days. Based on the per diem rate of \$380 (\$220 – route + \$160 – aide), this contract must be reduced by \$55,100 (\$31,900 – route + \$23,200 – aide), for the 145 days remaining in the school year, establishing a final contract cost of \$13,300 (\$7,700 – route + \$5,600 – aide). This route transported a union student to and from DLC Warren in Warren.

 $\underline{\text{CS-}144}$  – Due to the deletion of the only pupil transported on this route, it was cancelled effective October 20, 2020, after transportation services were provided for 29 days. Based on the per diem rate of \$340 (\$300 – route + \$40 – aide), this contract must be reduced by \$51,340 (\$45,300 – route + \$6,040 – aide), for the 151 days remaining in the school year, establishing a final contract cost of \$9,860 (\$8,700 – route + \$1,160 – aide), This route transported a Clark student to and from New Road Somerset in Somerset.

<u>CS-179</u> – Due to the deletion of the only pupil transported on this route, it was cancelled effective September 18, 2020, after transportation services were provided for 9 days. Based on the per diem rate of \$365.10 (\$304.08 – route + \$61.02 – aide), this contract must be reduced by \$63,527.40 (\$52,909.92 – route + \$10,617.48 – aide), for the 174 days remaining in the school year, establishing a final contract cost of \$3,285.90 (\$2,736.72 – route + \$549.18 – aide). This route transported New Providence students to and from Academy 360 Upper in Livingston.

<u>CS-228</u> – Due to the deletion of the only pupil transported on this route, it was cancelled effective October 27, 2020, after transportation services were provided for 37 day. Based on the per diem rate of \$448 (\$398 – route + \$50 – aide), this contract must be reduced by \$64,064 (\$56,914 – route + \$7,150 – aide), for the 143 days remaining in the school year, establishing a final contract cost of \$16,576 (\$14,726 – route + \$1,850 – aide). This route transported a Union student residing in East Windsor to and from DLC Warren in Warren.

- <u>CS-234</u> Due to the deletion of the only pupil transported on this route, it was cancelled effective October 14, 2020, after transportation services were provided for 26 days. Based on the per diem rate of \$275.60 (\$245.10 route + \$30.50 aide), this contract must be reduced by \$43,269.20 (\$38,480.70 route + \$4,788.50 aide), for the 157 days remaining in the school year, establishing a final contract cost of \$7,165.60 (\$6,372.60 route + \$793 aide). - <u>CS-452</u> Due to the deletion of the only pupil transported on this route, it was cancelled effective October 19, 2020, after transportation services were provided for 29 days. Based on the per diem rate of \$299.99 (\$249.99 route + \$50 aide), this contract must be reduced by \$46,198.46 (\$38,498 route + \$7,700 aide), for the 154 days remaining in the school year, establishing a final contract cost of \$8,699.71 (\$7,249.71 route + \$1,450 aide). - <u>CS-485</u> Due to the district's request, this route was cancelled effective September 18, 2020, after transportation services were provided for 12 days. - $\underline{\text{CS-512}}$  Due to the deletion of the only pupil transported on this route, it was cancelled effective October 16, 2020, after transportation services were provided for 27 day. Based on the per diem rate of \$296 (\$211 route + \$85 aide), this contract must be reduced by \$45,288 (\$32,283 route + \$13,005 aide), for the 153 days remaining in the school year, establishing a final contract cost of \$7,992 (\$5,697 route + \$2,295 aide). This route transported a Plainfield student to and from Westlake School in Westfield.
- <u>CS-542</u> Due to the deletion of a West Orange student from this route who required a personal aide, the aide was removed effective September 2, 2020. Based on the contractor's bid of \$75 per day, the contract must be decreased by \$13,500 for the 180 days remaining in the school year. The amended total cost is now established at \$66,960. This route now transports students from West Orange to and from Phoenix Center in Nutley.
- <u>CS-581</u> Due to the deletion of the only pupil transported on this route, it was cancelled effective October 8, 2020, after transportation services were provided for 25 days. Based on the per diem rate of \$275, this contract must be reduced by \$42,625, for the 155 days remaining in the school year, establishing a final contract cost of \$6,875. This route transported Cranford students to and from Montgomery Academy in Basking Ridge.
- $\underline{\text{CS-588}}$  Due to the deletion of the only pupil on this route, this route was cancelled effective October 23, 2020, after transportation services were provided for 11 days. Based on the per diem rate of \$320 (\$260 route + \$60 aide), this contract must be reduced by \$20,800 (\$16,900 route + \$3,900 aide), for the 65 days remaining in the school year, establishing a final contract cost of \$3,520 (\$2860 route + \$660 aide). This route transported a Roselle Park student to and from Mt. Carmel Guild in West Orange.
