




(i) The Mapping Between 5-Level and 3-Level Placements














Visalla Unified School District has several district level parent councils. On Back to School Night families convene in the gym for a brief presentation before heading out to classrooms. During this time, the site principal provides information regarding Mt. This meeting is held during Back to School Night as this is the time we have the largest prains audience in a single setting.

School Site Council meetings take place after school hours as we have student members on the council. Meetings for the year are scheduled in advance to allow parents time to plan ahead and communicate any hard schedule conflicts. We are flexible in our ELAC meeting locations to make participation possible for parents who do not have transportation to Mt. Whitney for meetings. We will hold meetings at feeder sites to accommodate these parents. We will, within reason, accommodate parents who communicate a sites to accommodate parents who communicate a desire to participate in meeting, but are unable to do so due to transportation or conflicts with meeting

If requested by parents, we will provide for regular meetings to formulate suggestions and allow for participation, as appropriate in decisions relating to the education of their children. As with any other request or suggestion, we will respond as soon as possible. We value partnering with our parents in supporting the academic and overall success of their student.

Parents are welcome to volunteer. We ask they complete our volunteer application prior to participating in class activities. Parents are also welcome to observe class activities. We request prior notice to ensure we are on a regular schedule for class times. Parents are asked to monitor their student's use of social media and the impact it may have at school.
- D) School staff reaches out to families not just to provide information or inquire about daily attendance, but in a genuine effort to support students. Teachers will contact parents to inform them if their student is failing a course. When students are struggling, parents are included in the support plan. When students are succeeding, successes are shared as well. Written communication home is provided in English as well as Spanish. VUSD provides a translation service sites may access to communicate with parents in a language sooken and understood by the family.
