Davis School District Policy 9th Grade Participation in High School Athletics

9 th grade student-athletes may try out for and participate at the high school level by agreeing to comply with the following policies:		
I recognize that I am not eligible to participate until this form is signed or initialed by all necessary parties		
Student/Athlete must meet the eligibility and academic standards required by the Utah High School Activities Association, Davis School District, and any school specific requirements.		
Ninth-grade students enrolled and attending a District junior high, may try out for and participate in UHSAA sponsored sports or activities: with the high school to which they would normally be assigned, based on residence, upon completion of the ninth grade; or with the high school to which they received a high school 9-12 open enrollment permit to attend, upon completion of the ninth grade; or allowing a student to play sports with the high school to which they would be assigned, based on an academic program feeder pattern. Students may apply for a permit during the open enrollment period of the student's eighth grade year.		
Student/Athlete agrees to pay applicable athletic fees (fee waivers granted to eligible students)		
Parent/Guardian assumes responsibility for transportation to practices and home contests		
Student Athlete leaves school early only to allow a reasonable amount of time to reach the bus departure site for AWAY games		
Student/Athlete misses no more than 1 class period for home contests		
Student/Athlete does NOT leave early for practices
