Student Resource Development/Student Leadership Grants

\$12,897 to support students, at all three levels- in regional and national competitions.

Whole School Improvement Grants

\$2,034 to engage the community and/or increase parent involvement in annual goals of the school, as well as to increase academic achievement of ALL students with a focus toward high-risk or academically challenged students.

Instructional Innovative Grants

\$16,704 to encourage, facilitate, recognize, and reward innovative and creative instructional approaches to the accomplishment of curriculum goals and objectives and/or Standards of Learning Objectives (SOLs).

Teacher Grants

\$4,300 to support teachers with their continued professional development and education, as well as, to promote teacher retention in York County Schools.

\$400 to support employees with their continued professional development and education.

Bay Electric Technology

\$3,800 in endowed funds to support technology in every school to purchase technology peripherals for instructional purposes, such as digital cameras, iPod Touches, eReaders, and allocated funds for technology needs in the future.
