Arrival and Dismissal Reminders

Thank you for making the Westview drop off and pick up go so smoothly and safely by following the daily traffic pattern. We appreciate your patience and concern for student safety as we get students into and out of the building. As a few reminders, when picking up or dropping off students please do not park in the drop off lane and come into the building as this slows the line of traffic. If you need to park and exit your vehicle, please park in a designated parking spot. For student safety please do not allow your students to get out of your vehicle on Ward Road and let them walk across/through traffic. In the morning we will begin unloading cars and buses at 8:55 AM (Mondays-Thursdays) and 9:55 am on late start Fridays, please pull all the way to the end of the line and wait for a staff member to give permission to exit the vehicle. Dismissal at the end of the day is at 4:10 PM.

Walkers and Bike Riders: It is important for students to use the crosswalk on Ward Road when walking or riding their bikes to school. Walkers and bike riders will enter the building by the front doors near the gym with bike racks available for students to secure their bicycles.

Reporting a Student Absence

Please notify the Westview office when your child will not be in attendance. You are able to report your child's absence 24 hours a day by calling 816-986-1353, leave your name, the child's name, teacher, grade and reason for absence. You



are also welcome to call the main office at 816-986-1350 during office hours. Office hours are 7:40 am - 4:40 pm.

Arriving Late to School or Early Pick Up

When students arrive after the bell has rung for the start of school to begin, please bring your student to the southside doors (car rider drop off and pick up side), ring our buzzer on the right side of the door, and the office will answer. It is encouraged for the adult dropping off the student(s) to come in to check in the student and to ensure the student arrives safely inside. The office will get the student off to class.

The same procedure will be followed when picking up a student early from school. The adult picking up the student will come to the same doors, ring the buzzer, announce that they are here to pick up a student (give student name), reason for pick up and their name. Please have your identification ready at the door to verify who is picking up the student.

I know parents are getting a lot of information, so I just wanted to send a quick email with some information you can look over at your convenience.

Some important things to note:

If your child needs school supplies and/or a backpack please reach out and let me know and we will get them what they need.

A reminder to fill out the free and reduced meals paperwork to see if you qualify for meal assistance. Application link is below in the Nutrition Services information section. If you need any help with the paperwork or have any questions don't hesitate to reach out.

Coldwater Creek Church partners with Westview to distribute weekly food bags to our students to take home every Friday. The Harvesters Backsnack program is available free of cost to any Westview student. They are planning to start sending bags home the first week in October. If you would like to sign your child up for the Backsnack program, call or email me and I will get them on our list. Please don't hesitate to reach out if you have any questions! Changes in Student Transportation Home

If there is a change in your student's normal dismissal from school, please notify the office by sending a note with your child that morning or by an email. If emailing the office, make sure to include the classroom teacher, both office secretaries and YClub (if the student attends YClub). This will ensure all the necessary WVE staff are aware of the changes in the afternoon transportation for your student(s). If changes arise during the day, please call the office at **816-986-1350** and notify the office **before 3:30 pm**. As a reminder, if students are dismissing with a friend, we require a note from **both** sets of parents giving permission for this transportation change. Your cooperation is greatly appreciated to assure all of our students arrive home safely.

Missouri Assessment Program

The Missouri Assessment Program (MAP) Grade-level Assessments evaluate student's progress toward Missouri Learning Standards. Each test produces an Individual Student Report (ISR) that includes Achievement Level and a short description of the knowledge and skill that are typically demonstrated by students in each achievement level. Currently, student ISRs are available in the DRC Insight platform and may be obtained at your request. Westview Elementary plans to distribute ISR reports on **September 7th**.

Chromebook Questions or Issues??

Here are some tips and procedures if your student's Chromebook is not working:
Charge and power on the device. If your Chromebook will not charge/power on, please follow these instructions: Charging your Chromebook
If you still can not power on your Chromebook OR if there is something else wrong (broken screen, charger broken, etc.) please go to the following link where you can see troubleshooting tips and submit a help desk ticket if needed: https://connect2learn.lsr7.org/support/. When submitting a ticket, be

sure to log in using the student's login and password.









- If you submit a help desk ticket, a technician will contact you with further instructions.

- If you are unable to submit a help desk ticket, please drop your student's Chromebook and charger off at their school.

- Once repaired, the device will be ready for pickup at your student's school. Schools will communicate a pick-up schedule as we near the start of school.

Emergency Drill Practice

Periodically throughout the school year your student may come home talking about having an emergency drill as they share their day with you. During the months of August and September, our classroom teachers will practice our emergency drills with their students. We will hold a school-wide tornado drill on September 1st, lockdown drill on September 7th and a fire drill on August 29th. We conduct a fire, tornado or lock down drill on a monthly basis, so please do not be alarmed if your student talks about a drill that happened at school that day. If there is an incident at school where emergency procedures are initiated and not in a drill format, information will be sent to parents via our automated "SchoolMessenger" calling system or information through a letter to parents. Our goal is to keep the lines of communication open and parents aware of school day events.

Late Start Fridays

Again this year, late start days will be on **all Fridays**. Every Friday will be a late start. Classes will begin one hour later at 10:10 am. Buses run on a one hour late schedule. Our dismissal time of 4:10 pm remains the same.



Back Snack Program

During the school year we have the opportunity to share a backpack of food with children on the last day of the school week, each week. Coldwater Creek Church partners with Westview to distribute weekly food bags to our students to take home every Friday. District Information

LSR7 2023 Food Service Management Policy: Policy EF : FOOD SERVICE MANAGEMENT

Administrative Form EF-AF(1) : FOOD SERVICE MANAGEMENT - (Nondiscrimination in School Nutrition Programs)

All students that attend Lee's Summit R 7 are provided the opportunity to purchase meals at each school cafeteria in accordance with the National School Lunch/Breakfast Program. The following guidelines shall be followed in the instance that a student finds it necessary to charge their meal due to a lack of funds in his/her account.

Parents/guardians are solely responsible for providing their children with meals, either through money to purchase meals at school or by packing a meal from home. If for any reason a parent/guardian cannot afford to provide a meal for their child, they can apply for Free and Reduced meal benefits. A hard copy application may be printed from our district website at: www.leessummitschoolnutrition.com. Applications (in most languages) are available. A household may also apply for free and reduced meals online at: www.heartlandapps.com.

Parents/guardians are encouraged to deposit money in their student's meal account by accessing our nutrition online payment portal at: www.myschoolbucks.com to make sure adequate money is readily available to purchase school meals. This will eliminate the need

for parents/guardians to send money with the child each day. Parents/guardians can also deposit money by

sending a check or cash directly to the school or with their student in an envelope with the student's ID number, name and amount of deposit.

Notice

At the beginning of each school year, a copy of this procedure will be provided to every parent/guardian in the district as required by law. In addition, a copy of this procedure, along with information about free and reduced-price school meals, will be provided to the parents/guardians of all students who enroll after the beginning of the school year.

A copy of this procedure will also be provided to all building administrators, staff responsible for collecting payment for meals at the point of service, staff involved with notifying parents/guardians about account balances, school social workers, nurses, counselors, the district liaison for homeless children and youths, and any other staff who regularly assist students in need.

Employees

Employees will not be allowed to charge meals.

Interventions

The district will provide the following notifications when a student reaches specific unpaid meal charges: 1. After a student accumulates \$5.00 of unpaid meal charges, School Messenger will notify household of negative account balances not more than two times per week.

2. Nutrition Services will provide administration a list of student charges on a weekly basis.

District employees are mandated by the state of Missouri to report any instances of suspected abuse or neglect to the Children's Division (CD) of the Department of Social Services. District personnel will report to the CD any instance where a student's arrival at

school with no provision for food leads to a reasonable cause to suspect neglect. Additionally, the district will provide the following interventions via the principal and/or counselor:

1. Meet with the student to assess to the extent possible whether the student or the student's family is experiencing hardships, barriers or other circumstances with which the principal or counselor could assist. 2. Make repeated attempts to contact the parents/guardians to inquire about any assistance that might be needed to complete the free and reduced price meals application, discuss the situation and any other concerns the principal or counselor may have after meeting with the student, provide other resources as applicable and resolve the situation.

3. Provide other resources as applicable.

Notifications to Parents/Guardians

The district will provide timely notification to parents/guardians when account balances run low (when applicable) and when account balances include unpaid charges. Parents can sign up for free at www.myschoolbucks.com to receive emails for low balances.

Debt Collection Delinquent Debt

Unpaid meal charges will be considered a delinquent debt 90 days after notice that charges are due when no payment or payment plan agreement has been made. Unpaid charges will be considered delinquent as long as the district determines the debt is collectible and efforts to collect the debt are ongoing. The district will make reasonable efforts to collect delinquent debt, including turning over unpaid meal charge balances to a collection agency when the superintendent or designee determines such action is in the best interest of the district. The district's Nonprofit School Food Services Account (NSFSA) funds may be used to cover the costs of reasonable efforts to collect delinquent debt, including costs associated with using a collection agency.

Bad Debt

When the district determines that collection of delinquent debt is impossible or too costly, the debt will be reclassified as bad debt. Bad debt is debt that will be written off as an operating cost. These costs must be restored using nonfederal funds. NSFSA resources

may not be used to cover any costs related to bad debt. Instead, local funds will be used to cover the costs.

End of Year Negative Balances

By law, Nutrition Services is not allowed to pay for bad debt. Therefore, each school will pay for their student's outstanding meal charges at the end of each year. Parents may be required to re-pay the school when the following year enrollment is conducted.

Donations

The district accepts donations from individuals or groups to help students and their families clear delinquent meal debt. Except as provided in policy KH, donations for delinquent meal debt can be made to the Nutrition Services Angel Fund or to individual schools. Donations are accepted at Nutrition Services (702 SE 291 Highway, Lee's Summit, MO 64063) or at the school cafeteria.

Refunds

Any student accounts with positive balances at the end of the school year will be automatically carried over to the next school year. If requested, the balances will be refunded to the account owner. Students who will be graduating or have left the district will have account balances refunded to the account owner or transferred to another student account at the request of the account owner.

Unclaimed Funds

All refunds must be requested within 90 calendar days of the last day of the current school year. Unclaimed funds (under \$5.00) for graduated seniors will be refunded at each school's cafeteria prior to the last day of the regular school year. Unclaimed funds \$5.00 or greater for graduated seniors will be refunded by the district during the month of June, annually. After 90 calendar days from the last day of the current school year, unclaimed funds of students no longer enrolled, become the property of the Lee's Summit R 7 School Nutrition Services Angel Fund.

Records

The district will maintain detailed records pertaining to delinquent and bad debt, including:

- 1. Evidence of efforts to collect unpaid meal charges.
- 2. Evidence that collection efforts fell within the time frame and methods established by this procedure.
- 3. Financial records showing when delinquent debt became bad debt.
- 4. Evidence that funds written off as bad debt were restored to the NSFSA from nonfederal sources.

Nondiscrimination Statement

2023-24 School Year

Dear Parent or Guardian:

The Lee's Summit School District is required to inform you of certain information that you, according to the "Every Student Succeeds Act of 2015 (ESSA) Public Law 114-95, have the right to know.

Upon your request, our district is required to provide to you in a timely manner, the following information:

- Whether your student's teacher has met State qualification and licensing criteria for the grade levels and subject areas in which the teacher provides instruction.

Dear Westview Families,





Westview Elementary is one of the lucky LSR7 schools in our District to have a facility dog on staff. Mocha is a 4 year old Anatolian Shepherd/ Great Pyrenees mix. This will be Mocha's second year at Westview, and she is very excited to return and see her "people". Mocha is kind, loving, patient and enjoys working with kids! We will be going to each classroom for new students to meet Mocha and for returning students to give her some love. We will also go over the expectations regarding Mocha. I am going to ask that you talk to your child(ren) about the expectations as well, which I am including in this letter. I know they get so excited about Mocha, so the more they hear these expectations the better. Last year, the students did an AMAZING job with Mocha and following the expectations. The expectations of **"Approach, Ask, Pet, Goodbye"** are what we will use and talk with the students about.

Approach= Think to yourself, "Self, is this a good time to come and say hello to Mocha?" Leaving the classroom or jumping out of line in the hallway are NOT responsible times to come and pet her. You should just wave to her or show a heart with your hands to her. When students approach Mocha, they need to WALK up slowly and calmly. Mocha usually only likes 4 or less students around her at a time. If there are already 4 students, you will need to wait for someone to leave before you approach.

Ask= This is a key safety measure both for Mocha and the kids. Students must ask to pet Mocha, and the adult with Mocha must respond back to them BEFORE they pet her. This ensures that the adult is aware of the interaction between Mocha and the student.

Pet= Mocha needs to be sitting/laying down and paying attention to the student wanting to pet her. Sometimes in the hall (mornings and afternoons) you can pet/swipe as you pass, but for the classroom, she needs to be sitting or laying down.

Goodbye= Only 4 students are allowed to be around her at a time. We need to set the expectation that saying hi to Mocha is a quick process (Swipe and Go) if there are others present that would like a turn to pet/swipe.
