The purpose of this agenda item is to award the Best Value Contractor (Scoggins Construction) for PSJA ISD LBJ Middle School Additions and Renovations Competitive Sealed Proposal # 20-21-044 and authorize the Superintendent to execute the contract for construction not to exceed \$12,128,787 for the 2020-2021 school year.

The attachment reflects the value engineering tabulation on the advertised proposal.

The District's Construction Team is recommending adding an alternate of \$350,000 to replace the HVAC equipment and controls in compliance with ASHRAE Coronavirus Standards 62.1 air quality requirements to be reimbursed from Federal ESSER Funding.
