3. ADMINISTRATIVE REPORTS

A. Report from Assistant Superintendent, Curriculum and Instruction

Melissa Szymanski:

- Logistical preparations for our March 9-11 Tri-State visit to Hastings are well underway and we are eager to welcome our critical friends from throughout the region. The focus of our visit, which is collaboration, was determined with our Chair Council. Our visit will be guided by three essential questions designed by Hastings faculty:
 - 1. To what extent, and in what areas, does the district have clear and well-understood protocols for systemic communication in service to a professional community for teachers and staff?
 - 2. To what extent are stakeholder roles and responsibilities understood and adhered to in service to a professional community for teachers and staff, a shared vision and environment for change, and parent and community support?
 - 3. How might we strengthen protocols, structures, and norms to enhance intradistrict collaboration in service to a professional community for teachers and staff?
- While our visit will include a document review, interviews with various stakeholders will be the key source for illuminating understanding of the Hastings system for the visiting team. The steering committee has requested that at least some Board of Education members participate in the interview process. Please let me know if you might be willing. A Google Form will be sent to the broader community in early February to solicit Hastings parents who are interested in being interviewed. A briefing prior to the visit will be held for anyone participating in the interview in order to share what to expect and to answer any questions.
- Last week's Professional Learning Committee session was focused on planning for the March
 Superintendent's Conference Day. While planning is still in progress, the team has focused the day on
 Culturally Responsive Pedagogies, which connects with one of the leadership goals that are applicable
 district-wide. At this time, the committee is recommending a keynote speaker followed by a choice of
 workshops, all of which are in the process of being finalized. Collaborative instructional planning time has
 been scheduled for the afternoon so new learning can be applied to practice. All faculty, including TAs, aides,
 monitors, clerical staff, and custodial staff will be participating in this learning day.
- Although our beloved science consultant, Helen Pashley, has retired, our district-wide efforts to align to the New York State P-12 Science Learning Standards are still underway. Because this work is so critical, we took great care to identify the right person to partner with us. Initially, Melissa Shandroff, Science Department Chairperson, and I consulted with BOCES for a recommended successor. Our regional science consultants were not available to support districts this year but suggested an outside consultant team for our consideration. We issued an RFP, to ensure that we cast a wide net, and this recommended team responded. While extremely impressive and knowledgeable, after meeting with them Melissa and I agreed to continue looking. We issued the RFP again as we continued to probe regionally and speak with colleagues. Liz Mirra was ultimately identified after taking these steps. As a business item on tonight's Board of Education agenda, you will find the proposal submitted by her. Melissa and I are confident that she will be a strong partner for our continued alignment efforts.

B. Report from Business Official

Maureen Caraballo:

- Governor Hochul released her proposed state budget, which is the Executive Budget. Based upon the runs Hastings will be seeing an increase next year of approximately \$500,000, which is good news for the District. The Governor has kept her promise in phasing in the foundation aid to schools over the next three years. For over a decade we have been either seeing very modest or sometimes decreases in our state aid, this is the first time in a number of years where we are seeing increases. There was also an allocation of pre-school that was first introduced last year. Will be presented with our upcoming budget presentation, how our district plans on allocating those funds, how much we received and how we are thinking about using those funds next year.
- The Budget 101 Session originally planned for this week was in conflict with the PTSA, trying to reschedule for next week, once a date has been secured information will be blasted out to the community. We will be

looking to present our first draft of the budget at the beginning of February, the Budget 101 meeting is helpful for the community to understand the school budget a little better.

- Focused on the upcoming budget
- State Aid Projections as mentioned earlier we are seeing an increase in state aid.
- Looked at the Tax Cap calculation there is a calculation that the state provides to the district. Ours for this coming year would allow us to stay tax cap compliant, we can increase it an additional \$1.7 million under the tax cap legislation without needing an override.
- Preliminary Budget Discussions spoke about our drivers such as salaries and benefits, contractual obligations, the increase in utility costs, and some other goods and services due to inflation.
- Discussed how we will be picking up some expenses in the future that are currently being covered by federal money.
- During the pandemic we got a lot of federal funding around technology, discussed how it would impact our budget moving forward.
- Spoke about the debt service for our bond, borrowing very low, will have a tax impact.
