CALL TO ORDER

Jason Fernau called the regular meeting to order at 7:03 p.m.

Mr. Fernau recapped the activities going on in the District.

RECOGNITION

Brian Retersdorf, K-12 Music Coordinator and his team recognized a record number of 112 students. He thanked everyone for their support and congratulated Dr. Duca on his appointment.

Mr. Retersdorf explained that Music in our School Month has been running for 30 years and is to showcase different music departments. The District has the designation of Best Communities for Music Education for the last 6 years. Mr. Retersdorf explained the designation, and shared historical and statistical information regarding the Music Department and students.

Mr. Retersdorf shared fundraising opportunities and scholarships. He announced the POPS concert next Saturday. He shared the required processes for All County and NYSSMA student competitions. He thanked all of the staff, including Kelly Seymour and Chelsea Reeves for their work and shared an expression of gratitude.

Mr. Fernau congratulated the students and thanked supportive members of the community.

PUBLIC COMMENT

Joshua Memos, Ballston Spa student, stated Ballston Spa is the best high school around.

Steve Galish, Ballston Spa, expressed concern regarding the presentation regarding the results of the May 2022 state tests. He reviewed specific student results showing low proficiency in ELA and math. He stated it costs over \$24,000 to educate one child in the District and questioned the cost relative to the results. He also expressed concerns regarding the school district and parent

responsibilities, but stated that parents have 100% responsibility for their child. He stated that school administrators are woke and that parents must hold them accountable.

PUBLIC COMMENT

Jim Shear, Glenville, NY, discussed an article in the Gazette regarding Duaneburg’s BOE 5-2 vote not to do a survey and compared this to District’s BOE vote. He asked the Board if you don’t survey, “how do you know what they want?” He stated the Governor has a way to sneak around the legislature. He stated proactive advocacy often gets results.

Kris DuBuque, Ballston Spa, NY, spoke about per diem teachers and substitutes and offered a suggestion to, like the Village Board, to create committees to study issues. He noted the Building Leadership Team have been offered. He noted an ad from Saratoga Springs and stated their were people looking for part time work. He recommended creating committees to address issues.

BSATA, BSTA, CSEA, and PTA

Ms. Pusatere noted that BSTA Scholarship applications are due 3/31 and encourage applicants.

Tim Turbiak noted that the Milton Terrace Primo Pizza dine fundraiser went well. He also noted that March 10 is Annual Family Bingo night and thanked BACC for their support. He mentioned that the Ronald McDonald house charities, that the Gordon Creek fundraiser was a success, and that there is Malta Avenue gear available and orders due by March 12th
