CALL TO ORDER

Jason Fernau called the regular meeting to order at 7:00 p.m.

Mr. Fernau discussed the challenges and distractions of the past week. He voiced well wishes for the injured student who was struck by a car and discussed yesterday's District threat. He expressed thanks for everyone's actions and support.

Dr. Duca thanked those involved in responding to the threat made against the District. He outlined the actions of the day of the threat.

RECOGNITION

David Sunkes, Athletics Director, shared statistical data regarding the teams' GPAs; and recognized coaches, student athletes, and shared their accomplishments.

Coaches recognized their athletes and gave out certificates.

Mr. Sunkes recognized Harvey and Gene Staulters for their contributions to the District and its students.

PUBLIC COMMENT

Frank Rossi, Jr., Mayor of the Village of Ballston Spa, stated that recognizing the student athletics that had been a highlight to a tough week. As the Mayor, he discussed his actions regarding the swatting incident and his participation in training going forward. He then discussed his involvement in street safety conversations with the Town of Ballston and the District in the aftermath of the accident last week. He stated it was important for everyone to work together to provide increased safety.

Karen Parlapiano, Ballston Spa, acknowledged Mr. Staulters, and spoke in favor of increased pedestrian safety.

Kelly Buell, Malta, discussed safety in the schools. She shared her experience including her son's assault in school, and events that occurred during and after the District lock down.

Jason Gurtler, Ballston Spa congratulated the Scotties athletes on their accomplishments, and congratulated Mr. Staulters on his career. Mr. Gurtler questioned District placement of students during the threat and offered alternative suggestions.

Peter Skrika, Wilton, discussed fiscal responsibility and voiced his concerns regarding the reduction of support positions for special education students versus administrative increases in salaries. He voiced concern regarding critical support staff being undercompensated.

STUDENT GOVERNMENT REPORT

Student Government reported the Troupe's production of Mean Girls attracted 1,700 people. They thanked those that had supported students. They announced the Middle School's Veteran Drive had been a success and thanked all that supported the drive.

Student Government is hosting their Spring Fling Dance on 4/21 from 7-10 pm in the High School gym and Spirit Week activities begin the Monday before.

Student Government shared information regarding their Leadership Conference, and wished everyone a wonderful break.

SUPERINTENDENT'S REPORT

Smart Schools Bond Act

Jason LaMora, Director of Technology, shared information regarding the Smart School Investment Plan. He shared an overview, then focused on requirements of the Smart Bond Act. Mr. LaMora outlined the process for requesting the NYS Funds and how the funds would be spent on technology. He highlighted the IT initiatives, discussed long range planning and stated the costs were completely State Grant funded.

2023-2024 Budget Review

Brian Sirianni outlined the draft total budget. He shared the required components of the budget and highlighted each item within the components. He discussed the small changes from the February presentation.

Mr. Sirianni discussed each of the budget drivers, including debt service, health insurance and liability insurance cost increases.

Mr. Sirianni stated the District is still waiting on State Aid figures, but is hoping for quick decision to allow for adjustments. He then highlighted each of the budget's revenue streams.

Mr. Sirianni discussed the tax levy cap calculation vs the actual District levy. He stated the allowable cap was 7% for next year. He stated the actual levy was currently 3.1% and that the average tax payer could expect to see 1.0% to 1.5% increase depending on which town they were located in.

Dr. Duca shared the mission statement and the idea of the meaningful diploma for students. He discussed the fiscal commitments, the guiding principles of the budget, fiscal frameworks, and shared goals. He thanked the teams for the hard work done working on finalizing the budget draft.

Dr. Duca discussed CRRSA funding including the expiration date of the funding. He explained the migration of some staff positions and some programs from the grant to the general fund. He explained decisions were made to provide positive impacts for the highest number of students.

Dr. Duca then discussed the reductions in staffing and discussed the priority hiring process that is available for seven years for anyone affected by this reduction.

Dr. Duca discussed the implementation for each of the building levels regarding learning opportunities, the continued implementation of the K-12 multi-tiered system of support program, the commitment to improve District facilities to ensure safe and secure campus, and the creation of learning opportunities for Special Education Students.

Mr. Fernau stated the presentations would be available on the District's site.
