SUPERINTENDENT'S REPORT

Dr. Dragone stated the Health and Wellness Expo held on Saturday, March 4th in the WR gym had been great. He thanked Sheriff Zurlo for handing out bike helmets and the Ballston Spa Teachers' Association for handing out books.

Dr. Dragone thanked students, parents and staff for participating in the Science & Engineering Fair held on March 11th. He reported March was Music in the Schools Month and he provided information regarding upcoming events.

Dr. Dragone went on to report the spring Meet the Coaches night would be held on Monday, March 20th, and the High School play, <u>Addams Family, The New Musical</u>, would start on March 31st.

Dr. Dragone stated the BSEF Taste of Ballston Spa would be held on April 3, 2017.

Dr. Dragone reminded everyone of the Robotics Competition this weekend. He stated there would be teams from all over the world competing. He wished everyone good luck.

Student Recognition

Tracy DeRagon and members of the music staff recognized students in the program. Ms. DeRagon shared a multitude of accomplishments.

Kevin Schaefer offered support and congratulations to those in the program and Dr. Dragone thanked everyone for the hard work and the excellent results.

2017–2018 Budget

Dr. Dragone stated he would present a State Aid update, share a revised draft budget and share the next steps. He discussed the Foundation Aid deficit and shared Foundation Aid from a historical perspective. Dr. Dragone discussed the Foundation Aid per pupil, and shared the ECB recommendations.

Dr. Dragone shared the Assembly One House Budget and the Senate One House Budget. He presented a slide illustrating Foundation Aid and the recommendation of all concerned groups.

Dr. Dragone reviewed the Tax Levy Limit Calculation, and discussed the Globalfoundries depreciation.

Dr. Dragone provided the draft budget comparison summary for the 2016-2017 to 2017-2018. Dr. Dragone stated the current planned increase was 2.1%. He gave the breakdown for each of the components of the budget.

Dr. Dragone discussed the staffing recommendations that had been presented at the last meeting.

Dr. Dragone discussed the propositions, including Vehicle Purchase, Ballston Spa Public Library and BARC. He reminded everyone that the library and BARC were not district related.

Dr. Dragone shared the opinions of the State's superintendents regarding optimism and pessimism related to program funding and services for their students.

Dr. Dragone discussed the concerns regarding inadequate State Aid.

Dr. Dragone shared information on the Federal front, discussed the cuts at USDOE and shared information regarding Obamacare and ESSA.

Dr. Dragone discussed the Education Transformation Act of 2015

Dr. Dragone gave a summary and stated the district would continue to stay focused on the District mission.

COMMITTEE REPORTS

Nancy Fodera stated the Facilities and Safety Committee had decided to have a runaway test.

Ms. Fodera reported the Committee had discussed implementing additional security measures. She stated security was constantly being reviewed. Ms. Fodera stated the Transportation Department was also looking at different way to update security

Ms. Fodera stated the Facilities Pride Committee had discussed the removal of obsolete equipment. She went on to report the coffee shop was continuing to move forward.

Ms. Fodera gave an update on the current search for the Building Maintenance Supervisor.

Ms. Fodera reported the district's insurance company had been very responsive in the wake of the fire.

Additionally, Ms. Fodera reminded everyone the Taste would be on April 3rd. She stated the raffles would include the Ireland trip and the drawing for the Ireland trip would be done during the First Friday village event.

Kevin Schaefer reported the Policy Committee continues to meet and read draft policies. He stated the policies that had been completed were available to board members in the shared folder. He encouraged board members to look at the draft policies that had been posted for review.
