SUPERINTENDENT'S REPORT

Dr. Dragone welcomed everyone and stated there were great athletic recognitions this evening. He thanked everyone for the work that had been done for the Health and Wellness Expo. Dr. Dragone stated 45 of the district's partners had attended the Expo.

Dr. Dragone stated there were approximately 300 attendees at the Social Media Night. He thanked Janice McPhee and all the nurses for their work in obtaining the grant.

He went on to announce the Odyssey of the Mind and Robotics teams were moving on to the Word Finals Competition. He congratulated everyone.

Dr. Dragone reminded everyone about the Taste of Ballston fundraiser on Monday evening in the High School cafeteria.

Laurie Sickles distributed the BSEF grants. She stated it was the foundation's 20th anniversary. She announced the foundation had given just shy of \$340,000 to the district during the 20-years. She stated great work had been done making the BSEF proud to support the district.

The grant winners were recognized and given awards.

Mr. Schaefer congratulated everyone and expressed his gratitude for the well round view of the foundation and for the wonderful contributions to the district.

Dr. Dragone thanked Ms. Sickles and the foundation and encouraged everyone to attend the annual fundraising dinner on Monday evening from 6–8.

Dave Sunkes and the coaches of winter sports recognized their players. All players were given certificates.

- Dr. Dragone outlined the next steps in the budget process.
