Greetings from the Plattsmouth Alumni Association. As we write this newsletter, we have many exciting things happening in and around the Plattsmouth Community. In the fall of 2014, the official ribbon cutting for the new four lane Hwy 75 expansion between Plattsmouth and Bellevue was held. This expansion has provided a safer highway system between Plattsmouth and our friends to the north as well as bringing much needed economic development to our community. Since the road project was started, we have seen the addition of several businesses along the Hwy 75 corridor including, Hy-Vee, and two businesses still under construction, Woodhouse Ford and Bomgaars. The much needed development has strengthened our existing business community and paved the way for future development in and around the community.

The Plattsmouth Community School District is also flourishing with this new wave of activity. They are nearing the end of construction on the PACK Project (Plattsmouth Activities Center for Kids) which has upgraded facilities throughout the High School Campus with the addition of a new Baseball Stadium and artificial turf on the Football/Soccer/Marching Band field and a community Walking Trail. Academically our students are reaching high goals, graduation rates continue to be over 95% and the district has seen an increase in students option enrolling into Plattsmouth from surrounding areas including the Omaha Metro. The athletic teams have seen much success in the past year. A state appearance by our Cross Country Team. Our young (no seniors) Wrestling team sent 9 wrestlers to State. They were 3 points away from a 1st place trophy, finishing 3rd. The Boys' Basketball team will make their first appearance at the State Tournament since 1996. Our Marching Blue Devil Band received a Superior (1) Rating at the State contest last October. The Culinary Team took 1st Place in cooking (including various skill tests) at the Metro Community College 28 team competition and 4th in the business side of competition, ending up with a 2nd Overall Trophy.

In many communities it is a custom for Honor Classes (25-50-60-70, etc.) to give a gift to their alma mater. The POPS Foundation has worked with the School District to install a nearly one mile cement walking trail around the High School Campus. As part of this project nine resting stations complete with solar lighting, beautiful landscaping, trees and high quality benches for patrons to enjoy while using the trail. The Foundation is seeking sponsors for these areas and we thought this would be a great opportunity for our Alumni to help support the many programs and help beautify the campus. All donations are tax deductible through the Foundation and your class, business or organization will be recognized in several places. We hope that you will consider this opportunity to support Plattsmouth Community Schools. A photo opportunity will be available for all donors at the Alumni Banquet in May.



# PCS Community Walking Trail Champion



### **HALL OF FAME - Erika Pauly**



Master Sergeant Erika Pauly is a 1995 Plattsmouth High School graduate. Erika is the youngest daughter of Mike and Lynne Pauly. As a military kid, Erika grew up in many interesting places as the family moved with Mike's Air Force career. Erika was born in San Angelo, Texas. Other military installations she called home include Crete, Republic of Greece; Anchorage, Alaska; and Fort Meade, Maryland. After her father's retirement from the Air Force, he took a position, teaching math at Plattsmouth High School in 1992. Erika graduated with distinction in the top 10% of the 1995 class. Immediately following graduation she entered the United States Air force on May 31, 1995, hard work has brought her to the rank of Master Sergeant (Senior Non-Commissioned Officer). She has worked diligently on furthering her education while in the Air Force. She earned an Associate Degree in Information Systems Technology from the Community College of the Air Force and a Bachelor's Degree in Emergency Management from the American Military University. She was an honor graduate of the Air and Space Operations Center Personnel Recovery Qualification Course, and the Senior NCO Academy, Distance Learning and the Joint Professional Military Education Course, Distance Learning.

Erika's duties in the Air Force have taken her around the world. While at Davis-Monthan AFB in Arizona she was an ATO Automation Technician, with the 612<sup>th</sup> Combat Plans Squadron. From August 1998-August 1999, Senior Air Defense/Search and Rescue Controller, 85<sup>th</sup> Group at Keflavik Naval Air Station, Iceland. The next three years in Spangdahlem AB, Germany, she was Senior Emergency Actions Controller, 52<sup>nd</sup> Fighter Wing. Then to Davis-Monthan AFB in Arizona for

NCOIC Training, 335th Wing. From May 2005 to January 2008 was NCOIC ACC Reports, Langley AFB, Virginia. The next two years NCOIC Command and Control Operations Training, Policy and Procedures Branch, Strategic Operations Division, Directorate of Air and Space Operations. HQ Air Combat Command, Langley AFB, Virginia. August 2012 to February 2012, NCOIC Systems, 55th Wing, Offutt AFB, Nebraska. NCOIC Command Post Operations, 55th Wing, Offutt AFB. Since November of 2012 Erika has been the Superintendent SACCS Management Flight 625th Strategic Operations Squadron, at Offutt AFB.

Erika has accumulated over two and one half years deployed to hostile environment locations supporting multiple operations including Operation Southern Watch, Operation Joint Forge, Operation Enduring Freedom, and Operation Iraqi Freedom. Those deployments include: Deployed Contingency Theater Automated Planning System Operator, Operations Directorate, Joint Task Force-Southwest Asia, Riyadh, Kingdom of Saudi Arabia. Deployed Command Post Controller, Tuzia AB, Bosnia-Herzegovina, Deployed Command Post Controller, 455th Air Expeditionary Wing, Bagram AB, Afghanistan. Deployed Command Post Controller, 332nd Expeditionary Logistical Readiness Squadron, AL Qayyarah, Iraq. Deployed Combat Search and Rescue Controller, US Central Command Joint Personnel Recovery Center, Combat Operations 609th Air and Space Operations Center, Al Udeid, AB, Qatar.

When you look at the long list of achievements and awards in her Air Force career, you see that her over-achiever high school days have effected how she does her job. Erika not only performs to her best ability, but she also helps to set the standards of how others will achieve. She was selected to rewrite the Command Post Specialty Knowledge Test for the AF Weighted Airman Promotion System. The achievement list for Master Sergeant Erika Pauly, is loaded with words like: outstanding performer, team, excellence, achiever and achievement, meritorious, and superior. A few specific awards are: Meritorious Unit Award (twice), NATO Medal, Army Commendation Medal, Joint Service Achievement Medal, Air Force Commendation Medal (four times), Air Force Good Conduct Medal (six times), Global War on Terrorism Expeditionary Medal, NSSAV Command Post Testing Team Award, NCO of the Year, and Air Force Outstanding Unit Award (twice).

Being involved in her community, no matter which part of the world she calls home, is a large part of her life. She is a member of American Legion Post 56 and 40 & 8 Voiture Locale 1218 both of Plattsmouth, as well as a member of Offutt AFB's professional SNCO (Senior NCO) organization, Top III. From Afghanistan to Maryland to Nebraska, she has run for Arthritis, Juvenile Diabetes, and Breast Cancer Cure. Organized fundraisers for Children's AIDS Network, Airmen Against Drunk Driving, and Santa's in Blue. She has filled sandbags to control flooding waters and helped with highway cleanup. She is always willing to help with the proper Flag ceremony for POW/MIA Remembrance Day, Memorial Day, and the Plattsmouth Harvest Festival color guard.

In her address to the student body at the Hall of Fame induction ceremony, she said, "I must admit that I was both surprised and humbled by my selection into the PHS Hall of Fame. I did not think that what I was doing for my country and my community wasn't anything that anyone else wouldn't have done given the opportunity. But that's really what my education from Plattsmouth High School gave me: an opportunity. It was the choices that I made based on the opportunity that led me to being here today."

Master Sergeant Erika Pauly is an inspiration to our young JROTC cadets and the general student population. She is an inspiration and role model for our young women in regard to what they can achieve in our community, for our country, and in our world.

### Evelyn Vinduska McKnight, AuD

Evelyn, class of 1973, is the youngest of four children of Sophia (Bierl) <sup>36</sup> and the late Henry Vinduska. She grew up on the family farm south west of Plattsmouth. Evelyn has been "involved" from the beginning, growing up with Church, 4-H, music (family band), high school instrumental music, academic excellence, and various clubs while at PHS. Her sisters Carolyn <sup>60</sup> and Marilyn <sup>64</sup> and brother Lynn <sup>71</sup> are all PHS grads. After high school, Evelyn attended the University of Nebraska in Lincoln where she earned a Bachelor of Arts degree in 1977. In 1979 she received her Masters of Audiology from the University of Iowa. In 1980 she opened her audiology practice in Fremont, Nebraska. She was awarded her Doctorate of Audiology in May of 2004 from Central Michigan University in Mount Pleasant, Michigan.

In her audiology career she worked with or for: Professional Hearing Center, PC, Fremont, NE; Dr. Britt Thedinger MD Fremont, NE; Member of Nebraska Board of Hearing Aid Instruments; Educational Service Unit #2 Fremont, NE; Immanuel Hospital, Omaha, NE; Veteran's Administration Hospital, Omaha, NE; Grant Wood Area Education Agency, Cedar Rapids, IA; and has given many presentations on hearing loss.

### Thomas A. McKnight, MD

Tom, class of 1971, is the second of four children of Cecil and the late Lila McKnight of Plattsmouth. . Tom was a busy high school student in cross country, basketball, and track, vocal and instrumental music, Student Council, National Honor Society, '71 Class President, and Salutatorian of his class. His brothers Jim<sup>70</sup> and Scott<sup>75</sup> and sister Jodi<sup>76</sup> are also PHS grads. After high school he earned a Bachelor of Science degree in Biology from Nebraska Wesleyan University in 1975. After just three years at Wesleyan he started Medical School at the University of Nebraska Medical Center in Omaha. Tom earned his MD in 1977. He completed a family practice residency in Cedar Rapids, lowa where he was Chief Resident. In 1981, after residency, he volunteered as a physician with Project USA, serving public health hospitals in Mescalero, NM; Browning, MT; and Barrow, AK. He then established a family medicine private practice in Fremont, NE where he continues to serve the community today. He is certified through the American Academy of Family Physicians. He has served on numerous committees for the Fremont Area Medical Center as well as the Medical Center medical staff. He is medical director for numerous local industries, schools, and church and Boy Scout camps.

Medical research is an important part of his practice. He has participated in clinical trials for the National Institute of Health as well as pharmaceutical companies. He has evaluated medications for migraine headaches, fungus infections, arthritis, high cholesterol, diabetes, herpes zoster, high blood pressure and flu. Tom is on the University of Nebraska Medical Center volunteer faculty and has enjoyed mentoring many medical students throughout the years. In 1980 he wrote "Lymphadenopathy in a Family Practice" for the American Association of Family Practice publication.

Tom's diverse interests keep him involved on boards and committees in many community organizations. A small sampling is: serving as local high school sports physician, promoting youth involvement in running, the Dodge County Crisis Center physician and the Nebraska Beekeepers Association. He works with many different organizations at the Mt. Michael Benedictine High School.

On October 8, 2014 - Dr. Thomas A. McKnight was named the 2014 Nebraska Family Physician of the Year


Evelyn and Tom married in July of 1979. They have three sons who learned the importance of family, community, hard work, world geography & history, and compassion for the world's people through family experiences. Tom and Evelyn learned quickly that to have a real day off meant leaving town. Travel gave them many learning experiences. Travel to South America, was not only an outdoor classroom, but became a "mission" opportunity to share medical supplies and skills with people who needed help. As a family they served many holiday dinners in soup kitchens. All three boys went into the "family business" of medicine. They all received their MD from the University of Nebraska Medical Center. Luke in 2008, is a hospitalist (Internal Medicine) at Ohio State Medical Center, his wife Erin, MD is in an advanced fellowship in adolescent medicine. Curtis in 2009, is a staff psychiatrist at St. Joseph's Hospital in Scottsdale, AZ, his wife Holly DDS, is a Periodontist. Alex in 2013, is in ENT residency at Wake Forest, North Carolina, his wife Kristen, is an ultrasound technician. Tom and Evelyn have one grandson, Lincoln and two more on the way. The family remains active members of St. Patrick Catholic Church, baseball, soccer, camping, water and snow skiing activities and lots of extended family time. They have a mix of allegiances in college sports: Nebraska Huskers, Notre Dame, Ohio State, and Creighton. Tom also enjoys gardening, arborist activities, jogging, roller-blading and photography.

In 2000 their personal and professional worlds collided. Evelyn was diagnosed with breast cancer. Her battle with cancer included several surgeries, radiation treatments, chemotherapy, and a stem-cell transplant. When there seemed to be a light at the end of the tunnel Evelyn was diagnosed with Hepatitis C (HCV). Tom's investigation of such puzzling and shocking news uncovered what became the largest Hepatitis C outbreak in U.S. medical history. His research showed cancer patients receiving chemotherapy at a private oncology clinic were being infected with contaminated syringes during treatments. Over 600 patients were notified, 450 were tested, 99 were infected with HCV, and 6 deaths were attributed to the HCV not their cancer. How is this possible anywhere in our country with Healthcare Professionals in charge?

Evelyn and Tom have used their personal experience to bring attention to and advocate on behalf of, safe injection practices. In 2006, they used Evelyn's malpractice award as seed money to establish a non-profit foundation to promote safe injection practices called Hepatitis Outbreaks' National Organization for Reform (www.HONOReform).

They developed and secured the funds for <u>The One and Only Campaign</u>, promoting the use of one syringe only one time. This is a national campaign to educate providers about safe injection practices and to empower patients to partner with their healthcare providers for safe healthcare. They have taken their story and plea for reform from a grassroots level in Nebraska and the Nebraska Legislature all the way to Washington DC where a Governmental Accountability Office investigation outlined the causes and possible solutions to the disease outbreaks that have resulted from unsafe injection practices. They have traveled the country educating professionals and the public. Their presentation, "Grieving and Growing through a Medical Tragedy" has been shared with students in medical and nursing schools, with designers and manufacturers of medical equipment, with insurance professionals and with victims of unsafe practice. Evelyn has been featured on CBS News, CNN, USA Today, the *Wall Street Journal* and *Newsday*. Evelyn has used her experience to co-author an award winning book with Travis Bennington, the lawyer for the majority of the 99 Nebraskans. *A Never Event: Exposing the Largest Outbreak of Hepatitis C in American Healthcare History*, the story of the Nebraska HCV outbreak. Evelyn and a survivor from a Colorado outbreak write a blog entitled "Survivor Stories" sharing personal stories of individuals regarding unsafe injections. Evelyn has written a chapter in a book about patient safety entitled: *The Truth about Big Medicine: Righting the Wrongs for Better Health Care*. In 2013 Evelyn was honored with awards from the Centers for Disease Control and the National Center for Emerging and Zoonotic Infectious Diseases.

Evelyn's treatments have been successful and she is Hepatitis free, she continues to advocate for safe practice. Their passion to educate the world has taken them to every corner of the globe. Visiting officials and laborers in India to explain the importance of changing syringe design in step with the One and Only Campaign. They continually testify to the policy makers of governments the importance of guidelines and laws to ensure safe practice. Tom and Evelyn just returned from Geneva, Switzerland where they testified at the World Health Organization meeting. As a result of their trip the injection safety campaign will be going to India, Uganda, and Egypt. Going Global!
