Transportation Updates

Transportation bus routes have been updated and rerouted for the 2023 -2024 school year. These revisions occur as needed due to changes in student enrollment and population. Bus routes are created for students to be transported from home (daycare/group home) to school and school to home

(daycare/group home) based on the closest, safest, shortest run possible for each student. For questions regarding bus transportation or to report an absence concerning transportation, call the transportation department at (810) 364-7757.

Parent Drop off/Pick up

Student safety is very important! Students may only be dropped off at the North Door, by Michelle Beeler's desk. Student school hours are from 8:45 a.m.- 3:00 p.m. If you are driving your student to school, please walk with them into the school vestibule, push the button to let school staff know your student has arrived, and sign them in on the clipboard. This is our record of attendance that your student has arrived at school for the day. Please follow the same process for dismissal if you are picking your student up early from school. Come to the school vestibule, push the button to let school staff know you are here to pick up your student, sign them out on the clipboard. This is our record of attendance that your student has been picked up and left school early for the day. Thank you for your help and understanding in this process!

Parent Drop off/Pick up - Rescue Medication - New Procedure

For families with students who carry rescue medication and are dropping off or picking up their student from school at any time, we will begin having both the parent/guardian and the school staff sign that the rescue medication has been delivered from home to school and has been returned from school back to home in our medication sign out binder. When you arrive at Woodland to drop off or pick up your student, push the button, and school office staff will call the classroom staff to come down to the North Door vestibule and exchange the rescue medication and both parties will sign in the book that the exchange has been completed. This process will allow us to be in alignment using the same process as Dean transportation when students are transported on Woodland buses.

Attendance Updates

A missed school day is a lost opportunity for students to learn. There are many learning activities that happen during the school day that cannot be made up. These include direct instruction from the teacher, guided practice on new material, the class read-a-loud, individual support from the teacher and more. Research shows a correlation between attendance and student success. Woodland will be working with families to ensure students are attending school on a regular basis.

Woodland Breakfast and Lunch 2023 - 2024

Woodland Developmental Center applied and has been approved for the Community Eligibility Provision (CEP) program again for the 2023-2024 school year. This means all students will be provided free breakfast and lunch for the entire 2023 - 2024 school year. Families will be required to complete a Household Information Report (HIR) that was sent home in the annual packet of forms from Woodland on the first day of school.

Annual Packet Information and Forms 2023 - 2024 School Year

As a reminder, annual school packets were sent home on July 10, 2023 for the new 2023-2024 school year. Thank you to the families that have completed their packets and returned them to school! We appreciate your assistance in getting these returned to us. We are still waiting on some packets to be returned. It is essential for your students' safety that we have current information and records on file. Please complete these forms and return them to your child's teacher promptly, if you have not already done so. On the student emergency card, critical information is provided; consequently, it is important that information is complete, up to date, and only individuals identified on the emergency card will be allowed to pick up your child from school. Should changes need to be made on your students' emergency card, these changes need to be made in person for safety and security. If you are unable to make these changes in person, please call the main office and we can send new cards home to be filled out. Reporting a Student Absence

Please ensure to monitor your children daily to ensure that they are not sent to school ill. If your child is going to be absent for the day please report the students' absence by calling the school office (810) 455-1011. In addition, please remember to call Dean transportation and let them know your student will be absent for the day as well. (810) 364-7757.

Emergency Drills

Throughout the school year, we will be practicing various emergency procedures as required by the state for fire, tornado, and lock down drills. If you hear your child or school staff talking about these events, please remember they are only drills. Should a real emergency situation occur, parents will be notified as soon as possible. St. Clair County RESA Asbestos Hazard Emergency Response Act (AHERA) 2021 Notification

The Environmental Protection Agency (EPA) requires each year, district workers and building occupants receive notification about asbestos activities such as response actions and inspections. The purpose of this correspondence is to meet those requirements and familiarize you with the asbestos-related activities that have been conducted in St. Clair County RESA during the past year.

MANAGEMENT PLANS

In 1988, St. Clair County RESA contracted an environmental consulting firm to conduct inspections and develop asbestos Management Plans for asbestos-containing material (ACM) within all district-owned buildings. These Management Plans are located in the administrative office of each building and are available to the public for review. A copy of each building management plan is also located at the Maintenance Building.

SURVEILLANCE ACTIVITIES

The AHERA regulation requires periodic surveillance of the condition of ACM every six months. The regulation also requires Reinspections conducted every three years by Michigan Accredited Inspectors. St. Clair County RESA has contracted with an independent consulting firm, Nova Environmental, Inc. to conduct the Reinspections. The last Reinspection was on March 22, 2022. Previous Reinspections and six-month periodic inspections can be located in the buildings' Management Plans.

ASBESTOS ABATEMENT

The last Asbestos Abatement at St. Clair County RESA was done in the TEC building by a certified Abatement Contractor on July 19-23, 2021. Annual Notification of Pesticide Applications

State of Michigan law requires that schools and daycare centers that may apply pesticides on school or daycare property must provide an annual notification to parents or guardians of students attending the facility.

Please be advised that the <u>St. Clair County RESA school/</u>daycare center utilizes an Integrated Pest Management (IPM) approach to control pests. IPM is a pest management system that utilizes all suitable techniques in a total pest management system with the intent of preventing pests from reaching unacceptable levels or reduce an existing population to an acceptable level. Pest management techniques emphasize sanitation, pest exclusion, and biological controls. One of the objectives of using an IPM approach is to reduce or eliminate the need for chemical applications of pesticides. However, certain situations may require the need for pesticides to be utilized.

As required by State of Michigan law, the school or daycare will provide advance notice regarding the non-emergency application of a pesticide such as an insecticide, fungicide or herbicide, other than a bait or gel formulation, that is made to the school or daycare buildings or grounds. Advance notice will be provided, even during periods when not in session. Advance notice is not given for the use of sanitizers, germicides, disinfectants or anti-microbial cleaners. In certain emergencies, such as an infestation of stinging insects, pesticides may be applied without advance notice to prevent injury to students, but the school or daycare will provide notice following any such application.

Advance notice of pesticide applications, other than a bait or gel formulation, will be given by at least 2 methods by which advance notice of the applications of a pesticide will be given at least 48 hours before the application. The first method will be by posting at the main entrance to the school / daycare center, which is located at 499 Range Road, Marysville, MI 48040. The second method will be by the method(s) checked below:

✓	Posting in a public, common area of the school or day care center, other than an entrance. We will post
	in the Front Office.
	E-mail.
	A telephone call by which direct contact is made with a parent or guardian of a student of the
	school/day-care center or a message is recorded on an answering machine.
	Providing the students of the school or children of the day-care center with a written notice to be
	delivered to their parents or guardian.
\checkmark	Posting information on the school or day-care center's web site.

Please be advised that parents or guardians of children attending the school or *day* care center are entitled to receive the advance notice of a pesticide application, other than a bait or gel formulation, by first class United States mail postmarked *at* least 3 days before the pesticide application, if they so request. If you prefer to receive the notification by first class mail, please contact Michelle or Kelley at the school office by calling (810) 455-1011.

Please be advised that parents or guardians of children attending the school may review the school's Integrated Pest Management program and records of any pesticide application upon request. Contact Russ Witherspoon, Supervisor of Maintenance
