Gloria Romero; Dr. Charles Heaton; Kelly Felton: Asked for approval from the board of the lease license agreement with Explore Academy Academy School.

Soren Williams, OUSD parent: There was no support for the academy from the OCDE but the board majority approved it anyway. They want to tear down public education with questionable charters.

Mike Tardif: The school will be serving Spanish-speaking families.

Rosa Otero: The school has one public grant from California. There is no outside money.

Michelle Loveland: School choice matters. We should have healthy competition. Public education matters and comes in different forms.

Legal Counsel Ms. Harden presented the item. During the discussion by the board, Trustee Erickson clarified that this is not a Charter School approval, just a license agreement for use and payment of facilities. The agreement is not a Prop 39 agreement and Explore Academy waived their Prop 39 for 2024-2025. There are no other Explore Academy sites operating in Orange County. Explore Academy will be paying \$74,476.82 for the 2023-2024 school year (\$6,770 per month). This will increase to \$84,514 for the 2024-2025 school year (\$7,000 per month). There are no educational services involved in the agreement. The agreement is based on space, regardless of the number of students. The agreement can be terminated with or without cause at any time. Olive Crest paid roughly \$16,000 per month which included additional portable classrooms, some owned by the district, and some by Olive Crest. President Ledesma clarified that the footprint of the land is the same, but Olive Crest had additional facilities that Explore Academy will not have. Legal Counsel Ms. Harden clarified that the square footage rate that the district charges is for building space and not land space.
