- 2. **Term.** You will agree to be employed an additional **15 days** for the <u>2022-2023</u> school year, according to the hours and dates set by the District as they exist or may hereafter be amended.
- 3. Credentials and Criminal History Review.
 - 3.1 **Certification and Licensure Requirement.** In order to qualify for Zone Salary Scale you must be fully certified, *credentialed*, and teaching as required by the specific needs of the District. You agree to maintain any applicable certification, permit, or licensure requirements throughout the term of this Contract Amendment. If you fail to fulfill the requirements necessary to extend a temporary or emergency certificate or permit, or if your certification or permit expires, is canceled, is relinquished, is suspended, or is revoked, the District may provide you with notice that this Contract Amendment is void.

4. Duties.

- 4.1 **General Standard.** You agree to perform the duties of your assigned position, as prescribed by state law and regulations and by the District, with reasonable care, skill, and diligence.
- 4.2 **Rules.** You agree to comply with all Board and District directives, state and federal laws and rules, and District policy and regulations, as they exist or may hereafter be amended.

5. Compensation.

- 5.1 **Salary.** The District shall pay you according to the Zone Salary Scale and the approved compensation plan adopted by the Board each school year.
- 5.2 **Annualized Salary.** Your salary will be paid out over 12 months, regardless of the work schedule.
- 5.3 **Local Supplement, Incentive, and Performance Pay.** If you qualify, you may receive local supplement, incentive pay and/or pay for performance under the District's compensation plan, federal law, or state law. A local supplement, incentive, or performance payment is not an entitlement as part of your salary.
- 6. **Termination of Contract Amendment.** Zone Salary Pay is a privilege not a right. This Contract Amendment will terminate if District Leadership is presented with sufficient evidence that employee is not meeting the expectations associated with Zone Salary Teachers, has failed to comply with Paragraph 3.1, or if Board determines that termination of your Zone Teacher Contract Amendment at the end of the contract period will serve the best interest of the District.

7. General Provisions.

- 7.1 **Severability.** If any provision in this Contract Amendment is held to be invalid, illegal, or unenforceable, the other provisions of the Contract Amendment will remain in full force and effect.
- 7.2 **Entire Agreement.** This Contract Amendment is in addition to existing Chapter 21 Probationary or Term contract and supersedes all existing agreements, verbal and written, between you and the District regarding your employment. This Contract Amendment does not constitute a "unified contract" with any supplemental duty agreement between the parties.
- 7.3 Applicable Law. Texas law shall govern construction of this Contract Amendment.

DEC (LOCAL)

PROPOSED REVISIONS

Leave Administration

The Superintendent shall develop administrative regulations addressing employee leaves and absences to implement the provisions of this policy.

Definitions

The term "immediate family" is defined as:

Immediate Family

- 1. Spouse.
- 2. Son or daughter, including a biological, adopted, or foster child, a son- or daughter-in-law, a stepchild, a legal ward, or a child for whom the employee stands *in loco parentis*.
- 3. Parent, stepparent, parent-in-law, or other individual who stands *in loco parentis* to the employee.
- 4. Sibling, stepsibling, and sibling-in-law.
- 5. Grandparent and grandchild.
- 6. Any person residing in the employee's household at the time of illness or death.

For purposes of the Family and Medical Leave Act (FMLA), the definitions of spouse, parent, son or daughter, and next of kin are found in DECA(LEGAL).

Family Emergency

The term "family emergency" shall be limited to disasters and lifethreatening situations involving the employee or a member of the employee's immediate family.

Leave Day

A "leave day" for purposes of earning, using, or recording leave shall mean the number of hours per day equivalent to the employee's usual assignment, whether full-time or part-time.

School Year

A "school year" for purposes of earning, using, or recording leave shall mean the term of the employee's annual employment as set by the District for the employee's usual assignment, whether fulltime or part-time.

Catastrophic Illness or Injury

A catastrophic illness or injury is a severe condition or combination of conditions affecting the mental or physical health of the employee or a member of the employee's immediate family that requires the services of a licensed practitioner for a prolonged period of time and that forces the employee to exhaust all leave time earned by that employee and to lose compensation from the District. Such conditions typically require prolonged hospitalization or recovery or are expected to result in disability or death. Conditions relating to pregnancy or childbirth shall be considered catastrophic if they meet the requirements of this paragraph.

Note:	For District contribution to employee insurance during
	leave, see CRD(LOCAL).

Availability

The District shall make state personal leave for the current year available for use at the beginning of the school year. Local leave shall be made available as earned.

State Leave Proration

If an employee separates from employment with the District before his or her last duty day of the school year or begins employment after the first duty day of the school year, state personal leave shall be prorated based on the actual time employed.

If an employee separates from employment before the last duty day of the school year, the employee's final paycheck shall be reduced for state personal leave the employee used beyond his or her pro rata entitlement for the school year.

Medical Certification

An employee shall submit medical certification of the need for leave if:

- 1. The employee is absent more than five consecutive workdays because of personal illness or illness in the immediate family;
- The District requires medical certification due to a questionable pattern of absences or when deemed necessary by the supervisor or Superintendent; or
- The employee requests FMLA leave for the employee's serious health condition; a serious health condition of the employee's spouse, parent, or child; or for military caregiver leave.

In each case, medical certification shall be made by a health-care provider as defined by the FMLA. [See DECA(LEGAL)]

State Personal Leave

The Board requires employees to differentiate the manner in which state personal leave is used.

Nondiscretionary Use

Nondiscretionary use of leave shall be for the same reasons and in the same manner as state sick leave accumulated before May 30, 1995. [See DEC(LEGAL)]

Nondiscretionary use includes leave related to the birth or placement of a child and taken within the first year after the child's birth, adoption, or foster placement.

Discretionary Use

Discretionary use of leave is at the individual employee's discretion, subject to limitations set out below.

DEC (LOCAL)

Request for Leave

In deciding whether to approve or deny a request for discretionary use of state personal leave, the supervisor shall not seek or consider the reasons for which an employee requests to use leave. The supervisor shall, however, consider the duration of the requested absence in conjunction with the effect of the employee's absence on the educational program and District operations, as well as the availability of substitutes.

Restrictions

Except as otherwise provided in this policy for a certain category of teachers, a supervisor shall not approve an employee's discretionary use of state personal leave for:

- 1. For more than five workdays in a semester;
- 2. For more than ten workdays in a school year; or
- 3. For more than three consecutive workdays.

An employee shall be approved to use no more than five leave days in a semester, and no more than ten leave days in a school year, for discretionary purposes.

Discretionary use of state-personal-leave shall-not exceed three consecutive workdays.

Local Leave

Each employee shall earn local leave in accordance with administrative regulations, to a maximum of ten paid local leave days per school year.

Local leave shall accumulate to a maximum of 90 leave days.

An employee's local leave balance shall be reduced to zero upon separation from employment for any reason.

Except as otherwise provided in this policy for a certain category of teachers, lelocal leave shall be used according to the terms and conditions of state sick leave accumulated before the 1995–96 school year; however, except that any employee may contribute local leave to the sick leave bank. [See DEC(LEGAL)]

Exception for
Discretionary Use of
State and Local
Leave

In accordance with provisions of the Board-adopted compensation plan, the work calendar for a teacher who has opted into the Zone pay scale shall normally extend beyond the instructional school year and beyond the work calendar for other teachers. If a teacher who has opted into the Zone pay scale has been absent fewer workdays than the total allotment of state and local leave days for the current school year, the teacher shall be allowed to request discretionary use of the remainder of the current school year's allotment of state and local leave during that extension period of the employee's work calendar, to a maximum of 15 consecutive workdays.

DEC (LOCAL)

Sick Leave Bank

The District shall establish a sick leave bank that employees may join through contribution of local leave.

Leave contributed to the bank shall be solely for the use of participating employees. An employee who is a member of the bank may request leave from the bank if:

- 1. The employee or a member of the employee's immediate family experiences a catastrophic illness or injury;
- The employee has exhausted all available paid state leave, local leave, and vacation days, and any applicable compensatory time; and
- The employee has been absent for more than five consecutive workdays.

The Superintendent shall develop regulations for the operation of the sick leave bank that address the following:

- Membership in the sick leave bank, including the number of days an employee must contribute to become a member;
- 2. Procedures to request leave from the sick leave bank;
- 3. The maximum number of days per school year a member employee may receive from the sick leave bank;
- The committee or administrator authorized to consider requests for leave from the sick leave bank and criteria for granting requests; and
- 5. Other procedures deemed necessary for the operation of the sick leave bank.

Appeal

An employee may appeal a decision regarding the sick leave bank in accordance with DGBA(LOCAL), beginning with the Superintendent or appropriate administrator.

Family and Medical Leave

FMLA leave shall run concurrently with applicable paid leave and compensatory time, as applicable.

Note: See DECA(LEGAL) for provisions addressing FMLA.

Twelve-Month Period

For purposes of an employee's entitlement to FMLA leave, the 12-month period shall be measured backward from the date an employee uses FMLA leave.

Combined Leave for Spouses

When both spouses are employed by the District, the District shall limit FMLA leave for the birth, adoption, or placement of a child, or to care for a parent with a serious health condition, to a combined

total of 12 weeks. The District shall limit military caregiver leave to a combined total of 26 weeks.

Intermittent or Reduced Schedule Leave The District shall not permit use of intermittent or reduced schedule FMLA leave for the care of a newborn child or for the adoption or placement of a child with the employee.

Certification of Leave

When an employee requests leave, the employee shall provide certification, in accordance with FMLA regulations, of the need for leave.

Fitness-for-Duty Certification

In accordance with administrative regulations, when an employee takes FMLA leave due to the employee's own serious health condition, the employee shall provide, before resuming work, a fitness-for-duty certification.

Leave at the End of Semester

When a teacher takes leave near the end of the semester, the District may require the teacher to continue leave until the end of the semester.

Temporary Disability Leave

Any full-time employee whose position requires educator certification by the State Board for Educator Certification or by the District shall be eligible for temporary disability leave. The maximum length of temporary disability leave shall be 180 calendar days. [See DBB(LOCAL) for temporary disability leave placement and DEC(LEGAL) for return to active duty.]

An employee's notification of need for extended absence due to the employee's own medical condition shall be forwarded to the Superintendent as a request for temporary disability leave.

The District shall require the employee to use temporary disability leave and paid leave, including any compensatory time, concurrently with FMLA leave.

Workers' Compensation

Note:

Workers' compensation is not a form of leave. The workers' compensation law does not require the continuation of the District's contribution to health insurance.

An absence due to a work-related injury or illness shall be designated as FMLA leave, temporary disability leave, and/or assault leave, as applicable.

No Paid Leave Offset The District shall not permit the option for paid leave offset in conjunction with workers' compensation income benefits. [See CRE]

Court Appearances

Absences due to jury duty or for compliance with a valid subpoena not related to personal or family issues shall be fully compensated by the District and shall not be deducted from the employee's pay

DEC (LOCAL)

Payment for Accumulated Leave Upon Separation or leave balance. An employee who is absent for any court appearance related to personal or family issues shall be required to use available personal leave.

The following leave provisions shall apply to local leave accumulated beginning on the original effective date of this program.

An employee who separates from employment with the District shall be eligible for payment for accumulated local leave under the following conditions:

- 1. The employee's separation from employment is voluntary, i.e., the employee is retiring or resigning and is not being discharged or nonrenewed.
- The employee provides advance written notice of intent to separate from employment. Contract employees must provide written notice at least 90 days before the last day of employment. Noncontract employees must provide written notice at least two weeks before the last day of employment.
- 3. The employee has at least 20 years of service with the District, including the last 15 consecutive years.
- 4. The employee has not previously received a payment for unused local leave.

The employee shall receive payment for each day of accumulated local leave, to a maximum of 90 days, at a rate of \$200 per day for a professional employee and \$100 per day for any other employee. If the employee is reemployed with the District, days for which the employee received payment shall not be available to that employee.

These rates established by the Board shall be in effect until the Board adopts new rates. Any changes to the rates shall apply beginning with the school year following the adoption of the rate change.

Upon termination of the Lease, the District may enter and repossess the premises and remove any property therein, without being considered guilty of trespass, eviction, forcible entry or detainer.

It is the responsibility of the District to annually execute a lease for each occupied employee housing unit. Leases signed after the school year begins must be processed promptly through the District's Business Office in order to deduct proper fees and forward information to the District's Payroll and Personnel Departments.

The District will prepare the lease in triplicate, obtain Tenant's signature, and maintain an accurate and up-to-date file. The completed lease copies will be distributed to Tenant and the District's Business and Personnel Offices. The lease document is a legal contract and may not be modified by oral statements.

In situations where Tenant moves from one rental unit to another, proper documentation must promptly detail the move. Landlord will initiate the Final Inspection Report for the vacated unit, initiate a new Employee Housing Lease for the newly occupied unit and a termination document would be executed for the formerly occupied unit. The original, non-refundable cleaning fee will be used for routine preparations and cleaning of the vacated unit. An additional non-refundable cleaning fee will be required for the newly acquired housing unit. An additional damage deposit will only be required if the initial deposit is needed for repairs to the vacated unit.

Rental Rates and Payroll Deductions

Payroll deductions will be made for charges in which the school district has an ownership interest including housing unit rental payment, damage fee deposit, non-refundable cleaning fee deposit, non-refundable pet deposit and monthly electricity payments. FSISD Lodge rooms are \$250 per month. By signing the District's lease agreement, Tenant agrees to payroll deductions for the payments indicated thereof. If Tenant is on District approved leave and does not earn enough to cover the deductions associated with the rental of school-owned property, Tenant is responsible for submitting the difference by check to the Business Office at 101 W. Division Street, Fort Stockton, Texas 79735, on or before the 25th day of the month.

Employee Housing Rental Rates:

Years 1 & 2 \$750 per month _____ Years 3 & 4 \$850 per month ____ Year 5 \$950 per month ____ Years 6+ \$1150 per month, increasing \$200 per month each subsequent year beyond 6

The rental deductions are made for the current month of occupancy, i.e., deductions on September payroll are for September occupancy, except for Tenant who owes back rent.

Receipts by the Business Office of the completed Employee Housing Final Inspection Reports are the proper authorization to discontinue rental deductions.

Cleaning and Damages Security Deposits

Tenant will pay the following deposits to the District Housing/Lodge:

Cleaning Fee - \$200/\$50 Damage Fee - \$200/\$100 Pet Fee - \$350/ N/A

The cleaning fee is a one-time, non-refundable deposit to cover the costs of routine preparations and cleaning of vacated units. The damage fee will be refunded if property is left clean with no required

repairs due to damages. The pet fee is a one-time, non-refundable deposit for those who choose to own pets and agree to adhere to the requirements set forth in the handbook at Section IX: Control of Pets.

This deposit shall be retained as long as Tenant occupies any school-owned housing or premises. If Tenant transfers from one rental unit to another, the deposit may be applied to any damages or cleaning fees sustained to the first unit and Tenant shall pay a replacement deposit for the new unit. Upon completion of the Employee Housing Final Inspection Report, the damage fee will be returned, less any amount retained, within 30 days. The District is responsible for completing the Employee Housing Final Inspection Report, with Tenant's signature, on any housing or premises vacated.

NOTE: Cleaning and damage deposit fees, as well as pet deposit fees, cannot be used to pay rent. However, these fees may be payroll deducted over a period of 10 months instead of a one-time payment, if Tenant enters into a lease in August of the school year. If the signing of a lease is beyond this time, the deposit fees will be prorated in order to allow for payment by May of the school year.

Contractual Landlord's Lien

The District has a contractual lien for unpaid rent that is due, and the lien attaches to nonexempt property that is in the residence as defined by §54.042 of the Property Code.

This contractual lien is in addition to the statutory Landlord's Lien provided by §54.041 of the Property Code. If Tenant defaults under this Lease, the District will have a lien upon all goods, chattels, or personal property of any description, not exempt by statute and belonging to Tenant, that is placed in, or becomes a part of, the premises, as security for rent due and to become due for the remainder of the current lease term. Tenant grants the District a security interest in all such nonexempt personal property placed in the premises. If the District exercises the option to terminate the leasehold and to re-enter and re-rent the premises as this lease provides, then the District, after giving Tenant reasonable notice of the intent to take possession and after giving Tenant an opportunity for a hearing, may take possession of all of Tenant's nonexempt property on the premises and sell it at public or private sale after ten (10) days' written notice to Tenant, for cash or on credit, for such prices and terms as the District considers best, with or without having the property present at the sale. The sale proceeds will be applied first to the necessary and proper expense of removing, storing and selling the property, then to paying any rent due or to become due under the Lease, with the balance, if any, to be paid to Tenant.

Subordination

This lease is subordinate to all recorded covenants and conditions now in effect — and to all ground or underlying leases, mortgages, or deeds of trust that may now or in the future affect — the real property of which the premises forms as part, including eases, mortgages, and deeds of trust that cover this real property and other premises as a blanket lien or otherwise, and to all renewals, extensions, modifications, consolidations, and replacements of them. This clause is self-operative; no further instrument or act is required to effectuate this subordination, but, in confirmation of this subordination, Tenant will execute promptly any certificate or other document that the District requests.

Prior Agreements Superseded

The Lease constitutes the sole agreement between the parties and supersedes any prior understandings or written or oral agreements between the parties respecting the subject matter.

Notices and Addresses

All notices to be given under the Lease will be given by certified or registered mail, addressed to the proper party, at the address listed herein for Landlord and at the lease premises for Tenant. The Fort Stockton

BACKGROUND:

The safety of our students and staff is our highest priority. Texas has several options that allows for district approved staff members to be armed in order to defend against active shooter threats.

The School Marshal plan is comprehensive with very specific state requirements.

The Guardian Plan allows for more local control.

FISCAL IMPLICATIONS:

Cost of training employees and depending on the plan cost of weapons etc.

RECOMMENDATION:

Task district leaders to discuss the topic with School Safety Committee. Seek public input, and develop a proposed Guardian Plan for the ISD.
