Sagamore of the Wabash - Kathy Friend

Dr. Mark Daniel, superintendent, presented the following information and recommendations concerning awards and recognitions:

RECOMMENDATION: It was recommended that the Board recognize Chief Financial Officer Kathy Friend for receiving the Sagamore of the Wabash.

RELATED INFORMATION: The Sagamore of the Wabash is the highest honor given by the Governor of Indiana. It is given to individuals who have provided a distinguished service to the State or Governor.

Kathy Friend joined Fort Wayne Community Schools on Jan. 18, 2000. She began her career at a CPA firm in Indianapolis after graduating in 1982 from IUPUI (she attended all but her last semester at IPFW) with a Bachelor of Science degree in accounting. She became a senior planner at Paul Harris Stores corporate office, and in 1988, she returned to Fort Wayne as the Director of Internal Audit for the City. She later became Deputy Controller and then City Controller.

As the Chief Financial Officer for Fort Wayne Community Schools, she has been a respected member of the Superintendent's Cabinet and a trusted leader throughout the State. She has served as FWCS' liaison with local legislators and the Indiana General Assembly, and it is often said that Kathy knows the State's Education Funding Formula better than anyone.

Kathy believes strongly in public education and fiscal responsible. She was a leader in moving FWCS to greater energy efficiency and spearheaded three successful capital referendums that brought FWCS' aging schools into the 21st century.
