Superintendent's Report:

Mr. Keaffaber reported that the projects continue to move along. The roof is still being worked on at Southwood Elementary and the gym floor at Southwood Jr/Sr High School is just about finished.

Curriculum Report:

Mr. Drake shared the IREAD scores with the Board. Although, scores are not as high as we would like, they are above the state average. Our schools are working to improve our small group reading support systems for younger students. Our schools and staff are also investing significant time and resources into the Science of Reading through LETRS training hosted by Region 8 ESC to help classroom teachers improve student reading.
