The Maywood School District is now accepting registrations for incoming kindergarten students for the upcoming school year 2023-2024.

Please follow the steps outlined below for the completion of the registration process.

Baseline Requirements

- **You (parent/parents) must be a resident of Maywood;**
- **The child wishing to attend Kindergarten must be living with you, the parent(s);**
- **The child must turn 5 on/or before October 1, 2023.**

STEP 2

Please call Memorial School at 201-845-9113 extension 8 to schedule your Kindergarten Registration appointment. Kindergarten Registration Appointment dates are February 22nd, February 23rd, February 24th, March 23rd and March 24th.

STEP 3

Please submit the following documents at your Kindergarten Registration Appointment.

- A copy of your child's original birth certificate or passport
- Four proofs of residency (Please see list below for examples of proof)
- One recent photo of your child
- Medical Records

STEP 4

The State of New Jersey requires that every student who is admitted to public school has evidence of the necessary immunizations. State law prohibits your child from attending school until all requirements are met.

FOUR (4) proofs of residency

The proof of residency must have the last name noted on the proof.

A photo ID is also required.

Homeowners must provide at least one of the items in **bold** plus 3 additional proofs.

Tenants must provide both items in **bold** plus 3 additional proofs.
