

# 2023-24 Affidavit of Residence for PARENT

## **READ - IMPORTANT INFORMATION**

A sworn notarized affidavit of residence is a *legal document* required for enrollment of a student if the student and his/her parent(s) reside in Pearland ISD with another family, in someone else's home. **Texas Education Code 25.001 and Texas Penal Code 37.10 require that the student AND parent must reside full time at the Pearland ISD address claimed and have no other home.** Violation of this will result in immediate withdrawal, fines from Pearland ISD to each party falsifying information, and possible charges under the Texas Penal Code for falsifying a government record. Pearland ISD will make periodic home visits to verify residence. Affidavits are valid for one school year.

Print clearly. N/A does not apply. **Do not leave any spaces blank.** The "resident" that you reside with must be the person who lives in the home and is named on the deed as owner or on the current lease as lessee to the home.
